17 department head of the institutions and departments referred to herein; provided that all contracts  
18 and projects and plans and specifications therefor shall be awarded in accordance with the  
19 provisions of RSA 21-I and RSA 228.

20 4 Expenditures; Community College System of New Hampshire.

21 I. The appropriations made for the community college system in paragraph II of section 1  
22 and the sums available for this project shall be expended by the trustees of the community college  
23 system of New Hampshire.

24 II. The appropriations made to the community college system in paragraph II of section 1  
25 are available for all costs incidental to the completion of the project enumerated including but not  
26 limited to the costs of the services for architects, engineers, and other consultants of such kind and  
27 capacity as the community college system board of trustees may, in its discretion, wish to employ on  
28 such terms and conditions as the board determines. These monies shall be spent under the direction  
29 of the community college system board of trustees and pursuant to the policies adopted by the board  
30 of trustees.

31 III. Any authorization contained in this act which is at variance with the requirements of

10          6 Land Acquisition. Any land acquired under the appropriations made in sections 1 and 2 of  
11 this act, if any, as may be acquired under the appropriation shall be purchased by the commissioner  
12 of the department of administrative services or the department of transportation with the approval  
13 of governor and council.

14          7 Bonds Authorized. To provide funds for the total of the appropriations of state funds made in  
15 sections 1 and 2 of this act, the state treasurer is hereby authorized to borrow upon the credit of the  
16 state not exceeding the sum of \$171,060,895 and for said purposes may issue bonds and notes in the  
17 names and on behalf of the state of New Hampshire in accordance with the provisions of RSA 6-A.  
18 The source of funds are as follows: General Fund \$137,678,945, Highway Funds \$10,000,000, and  
19 Other Funds \$23,381,950.

20          8 Payments.

21           I. The payment of principal and interest on bonds and notes issued for the projects in section  
22 1 shall be made when due from the general fund of the state.

23           II. The payment of principal and interest on bonds issued for the projects in:

24           (a) The highway fund portion of the appropriations made in section 2 shall be made from  
25 the highway fund and the general fund portion from the general fund.

26           (b) The fish and game fund portion of the appropriations made in paragraph V of section  
27 1 shall be made from the fish and game fund.

28          9 Powers of Governor and Council. The governor and council are hereby authorized and  
29 empowered:

30           I. To cooperate with and enter into such agreements with the federal government, or any  
31 agency thereof, as they may deem advisable, to secure federal funds for the purposes hereof.

32           II. To accept any federal funds which are, or become available for any project under sections  
33 1 and 2 beyond the estimated amounts. The net appropriation of state funds for any project for  
34 which such additional federal funds are accepted shall be reduced by the amount of such additional  
35 funds, and the amount of bonding authorized by section 7 shall be reduced by the same amount.

1 III. For any federal funds accepted under this section by the governor and council, the agency  
2 shall provide, within 60 days, the approved governor and council item as an informational item to  
3 the capital project overview committee and to the treasury department.

4 10 Transfers. The individual project appropriations provided in sections 1 and 2 of this act shall  
5 not be transferred or expended for any other purposes; provided that if there is a balance remaining  
6 after an individual project, which is fully funded by state funds, is completed, accepted, and final  
7 payment made, said balance or any part thereof may be transferred by governor and council, to any  
8 other individual project or projects, which are also fully funded by state funds, within the same  
9 section and from the same funding source, provided that prior approval of the capital project  
10 overview committee is obtained.

11 11 Reduction of Appropriation and Bonding Authority. If the net appropriation of state funds  
12 for any project provided for by sections 1 and 2 is determined on the basis of an estimate of  
13 anticipated federal, local, or other funds, and if the amount of such funds actually received or  
14 available is less than said estimate, then the total authorized cost for such projects and the net  
15 appropriation of state funds thereof shall be reduced by the same proportion as the proportion by  
16 which federal, local, or other funds are reduced. The amount of bonding authorized by section 7  
17 shall be reduced by the amount that the appropriation of state funds is reduced pursuant to this  
18 section.

19 12 Division of Public Works Design and Construction Inspection Services; Davis-Bacon Act  
20 Compliance. The appropriations for those projects which are managed by the division of public  
21 works design and construction, department of administrative services, may be expended to fund
