STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Five

AN ACT adjusting the minimum fine for attacks by nuisance dogs.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Penalties for Nuisance Dogs. Amend RSA 466:31-a to read as follows:

2 466:31-a Penalties.

3 I. Any person who violates any provision of RSA 466:31 shall be guilty of a violation;
4 provided that if such person chooses to pay the civil forfeiture specified in paragraph II, the person
5 shall be deemed to have waived the right to have the case heard in district or municipal court and
6 shall not be prosecuted or found guilty of a violation of RSA 466:31. Any person who does not pay
7 the civil forfeiture specified in paragraph II shall have the case disposed of in district or municipal
8 court.

9 II. Any person who violates any of the provisions of RSA 466:31 shall be liable for a civil
10 forfeiture, which shall be paid to the clerk of the town or city wherein such dog is owned or kept
11 within 96 hours of the date and time notice is given by any law enforcement officer or other person
12 authorized by the town to the owner or keeper of a dog in violation of RSA 466:31. If the forfeiture is
13 paid, said payment shall be in full satisfaction of the assessed penalty. The forfeiture shall be in the
14 amount as specified for the following violations:

15 (a) [~~\$25~~] **A warning** for the first nuisance offense under RSA 466:31, II(a), (b), (c) or (d);
16 [~~\$100~~] **\$50** for the second **offense committed within 12 months of the first nuisance offense**
17 **under RSA 466:31, II(a), (b), (c), or (d); \$100 for the third** or subsequent nuisance offense
18 committed within 12 months of the first nuisance offense under RSA 466:31, II(a), (b), (c) or (d).

19 (b) [~~\$50~~] **\$200** for the first menace offense under RSA 466:31, II(e) or (f); [~~\$200~~] **\$400** for
20 the second or subsequent menace offense committed within 12 months of the first menace offense
21 under RSA 466:31, II(e) or (f).

22 (c) [~~\$100~~] **\$400** for the first vicious offense under RSA 466:31, II(g). **Additionally, the**
23 **owner of the dog shall be liable for all medical bills sustained by the person who was**
24 **attacked.**

25 (d) [~~\$400~~] **\$1,000** for the second or subsequent vicious offense committed within 12
26 months of the first vicious offense under RSA 466:31, II(g). **Additionally, the owner of the dog**
27 **shall be liable for all medical bills sustained by the person who was attacked.**

28 III. Any person who pays a civil forfeiture specified in paragraph II 2 times in any 12-month
29 period according to the records of the town or city clerk, may not pay a civil forfeiture for subsequent
30 violations of RSA 466:31 in that 12-month period, but shall have those cases disposed of in district or

1 municipal court. In the case of a vicious dog, as described by RSA 466:31, II(g), where its behavior
2 presents a threat to public safety, immediate district court or municipal court proceedings ~~may~~
3 **shall** be initiated in lieu of the civil forfeiture.

4 ***IV. Nothing in this section is intended to limit any civil recovery that an individual***
5 ***may claim under RSA 466:19, or as otherwise allowed by law.***

6 2 Effective Date. This act shall take effect January 1, 2026.
