AN ACT repealing certain committees and commissions and relative to the membership of the New Hampshire rare disease advisory council.

AMENDED ANALYSIS

This bill repeals various committees and commissions, and removes the house and senate members of the advisory council on child care. This bill further removes the restriction that members of the New Hampshire rare disease advisory council not serve more than 2 full consecutive terms.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Five

AN ACT repealing certain committees and commissions and relative to the membership of
the New Hampshire rare disease advisory council.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Offshore Wind Industry Workforce Training Center Committee; Reference Deleted. Amend
2 RSA 12-O:51-a, III to read as follows:

3 III. The committee shall report annually by November 1 to the governor[~~the chair of the~~
4 ~~New Hampshire offshore wind and port development commission under RSA 374-F:10,~~] and the
5 president of the Business and Industry Association.

6 2 New Hampshire Rare Disease Advisory Council Established. Amend RSA 126-A:79, III to
7 read as follows:

8 III. Terms of office shall be for 3 years, except that legislative members shall serve the terms
9 coterminous with their terms of office. [~~No member shall serve more than 2 full consecutive terms.~~]

10 3 Repeal. The following are repealed:

11 I. RSA 4:9-p through 4:9-r and the subdivision heading preceding RSA 4:9-p, relative to the
12 New Hampshire recovery monument commission.

13 II. RSA 10:5 through 10:10 and the subdivision heading preceding RSA 10:5, relative to the
14 lakeshore redevelopment planning commission.

15 III. RSA 12-P:7-b, II(b), relative to the office of offshore wind industry development and
16 energy innovation supporting the offshore wind commission.

17 IV. RSA 12-O:55-a, relative to the commission on demographic trends.

18 V. RSA 17-J:5, relative to the joint legislative parking garage oversight committee.

19 VI. RSA 72:8-f, relative to the study commission on the assessing of power generation.

20 VII. RSA 105-D:2-a, relative to the commission to develop recommendations for legislation
21 to establish a single statewide entity to receive complaints alleging misconduct regarding all sworn
22 and elected law enforcement officers.

23 VIII. RSA 126-A:17, II(a) and II(b), relative to the house and senate members of the advisory
24 council on child care.

25 IX. RSA 127:12, relative to the commission to study the delivery of public health services
26 through regional public health networks.

27 X. RSA 276-B, relative to the task force on work and family.

13 generation.

14 4 Effective Date. This act shall take effect upon its passage.
