SENATE BILL **97-FN**

AN ACT relative to intra-district public school transfers.

SPONSORS: Sen. Sullivan, Dist 18; Sen. Pearl, Dist 17; Rep. Layon, Rock. 13

COMMITTEE: Education

ANALYSIS

This bill authorizes parents to transfer their children to other schools within their resident district as long as such school has the capacity to accommodate the student.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Five

AN ACT relative to intra-district public school transfers.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Change of School or Assignment; Best Interest of Student. Amend RSA 193:3, I to read as
2 follows:

3 I.(a) The parent or guardian of a student may apply to the superintendent of the student's
4 district of residence [~~if the parent or guardian believes it would be in the best interest of the student~~]
5 to change the student's school or assignment ***to another specific public school, public academy,***
6 ***or an approved private school within the district. The parent or guardian of a student may***
7 ***also apply to the superintendent of the student's district of residence if the parent or***
8 ***guardian believes it would be in the best interest of the student to change the student's***
9 ***school or assignment to another public school, public academy, or an approved private***
10 ***school which is outside the district. Unless the student is experiencing a manifest***
11 ***educational hardship, applications pursuant to this paragraph shall be made no later***
12 ***than July 1 for the upcoming school year.***

13 (b) [~~Upon such request~~] ***For requests to change assignments to schools outside the***
14 ***district, or for requests made after July 1 for the upcoming school year,*** the superintendent
15 shall schedule a meeting with the parent or guardian, to be held within 10 days of the request.

16 (c) Prior to or at such meeting, the parent or guardian shall make a specific request that
17 the student be re-assigned by the school board to another public school, public academy, or an
18 approved private school within the district or to a public school, public academy, or an approved
19 private school in another district. ***If such request is made to reassign the student to another***
20 ***public school, public academy, or approved private school within the school district, the***
21 ***superintendent shall approve the request unless it fails to meet the requirements under***
22 ***this section.***

23 (d) At such meeting, the parent or guardian may present documents, witnesses, or other
24 relevant evidence supporting the parent's belief that it is in the best interest of the student to change
25 the student's school or assignment. The superintendent may present such information as he or she
26 deems appropriate.

27 (e) ***In determining whether to authorize a request to transfer to another school***
28 ***within the district, the superintendent shall consider only whether the specifically***
29 ***requested school has the ability to accommodate the student based on existing school***

1 **capacity.** In determining whether it is in the best interest of the student to change the student's
2 school or assignment **to a school outside the district**, the superintendent shall consider the
3 student's academic, physical, personal, or social needs.

4 (f) If the superintendent finds it is in the best of the interest of the student to change the
5 student's school or assignment **to a school outside the district, or finds the requested school in**
6 **district has the ability to accommodate the student**, the superintendent shall initiate:

7 (1) A change of assignment within the student's current assigned school;

8 (2) The student's transfer to another public school or public academy within the
9 district of residence; or

10 (3) The student's transfer to a public school, public academy, or an approved private
11 school in another district.

12 (g) If a student is reassigned [~~as a result of a best interest determination~~] to a public
13 school or public academy **outside the district of residence**, the superintendents or administrators
14 involved in the reassignment shall jointly establish a tuition rate for such student. Some or all of
15 the tuition may be waived by the superintendent of the receiving district for good cause shown or
16 pursuant to school board policy of the receiving district. The school board of the student's district of
17 residence shall approve the payment of tuition upon the superintendent's finding that **it** is in the
18 best interest of the student to be reassigned. Transportation shall be the responsibility of the parent
19 or legal guardian.

20 (h) If the student is reassigned as the result of a best interest determination to an
21 approved private school, the private school may charge tuition to the parent or may enter into an
22 agreement for payment of tuition with the school district in which the child resides.

23 (i) If the superintendent does not find that it is in the best interest of the student to
24 change the student's school or assignment **to a school outside the district, or finds that the**
25 **requested school in district is unable to accommodate the student**, the parent or guardian
26 may request a hearing with the school board of residence to determine if the student is experiencing
27 a manifest educational hardship under paragraph II.

28 (j) The school board of each school district shall adopt a policy addressing instances in
29 which there are more requests to transfer to a school than there is ability to accommodate students
30 based on [~~teacher to student ratio and~~] existing school capacity pursuant to subparagraph (e).

31 2 Effective Date. This act shall take effect July 1, 2025.
