1 Amend the title of the bill by replacing it with the following:

3 AN ACT relative to the sale of surplus state-owned land.

5 Amend the bill by replacing all after the enacting clause with the following:

7 1 New Paragraph; Acquisition and Disposal of Real Estate. Amend RSA 4:40 by inserting after
8 paragraph III-a the following new paragraph:

9 III-b. Except as otherwise provided in RSA 4:39-c, RSA 228:31-b, and RSA 204-D, proceeds
10 from the sale, conveyance, transfer, or lease under this section shall be credited as restricted revenue
11 to the fund from which the property was originally purchased or that supported its acquisition.

12 2 Effective Date. This act shall take effect July 1, 2026.
