SENATE BILL **522**

AN ACT re-establishing the commission to study the economic impact of the arts and culture in New Hampshire.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty-Six

AN ACT re-establishing the commission to study the economic impact of the arts and culture in New Hampshire.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Subdivision; Commission to Study the Economic Impact of the Arts and Culture in New
2 Hampshire. Amend RSA 19-A by inserting after section 13 the following new subdivision:

3 Commission to Study the Economic Impact of the Arts and Culture in New Hampshire
4 19-A:14 Commission Established.

5 I. There is established a commission to study the economic impact of the arts and culture in
6 New Hampshire.

7 II. The commission shall consist of the following members:

8 (a) Three members of the house of representatives, one of whom shall be a member of
9 the commerce and consumer affairs committee and one of whom shall be a member of the finance
10 committee, appointed by the speaker of the house of representatives.

11 (b) One member of the senate, appointed by the president of the senate.

12 (c) One member of the state council on the arts, appointed by the council.

13 (d) The commissioner of the department of business and economic affairs, or designee.

14 (e) One member each from the division of the arts, the division of libraries, the division
15 of historical resources, and the New Hampshire film and television commission, appointed by the
16 commissioner of the department of cultural resources.

17 (f) One member from the board of directors of Arts4NH, appointed by the president of
18 the organization.

19 (g) One member from the board of directors of the New Hampshire Theatre Alliance,
20 appointed by that organization.

21 (h) One member from the board of trustees of the League of New Hampshire craftsmen,
22 appointed by the president of the board of trustees of the organization.

23 (i) One member from the board of trustees of the White Mountains Attractions
24 Association, appointed by that organization.

25 (j) One representative of the performing arts, appointed by the governor.

26 (k) One representative of New Hampshire art museums, appointed by the governor.

27 (l) One representative of New Hampshire history museums, appointed by the governor.

28 III. Legislative members of the commission shall receive mileage at the legislative rate when
29 attending to the duties of the commission.

1 IV. The commission shall study the economic impact of the arts and culture in New
2 Hampshire and recommend ways in which the state can enhance and expand this sector of the New
3 Hampshire economy. In the performance of its duties, the commission may solicit information and
4 testimony from local artists and any group or organization, and other states with information
5 relevant to the study.

6 V. The members of the commission shall elect a chairperson from among the members. The
7 first meeting of the commission shall be called by the first-named house member. The first meeting
8 of the commission shall be held within 45 days of the effective date of this section. Nine members of
9 the commission shall constitute a quorum.

10 VI. The commission shall report its findings and any recommendations for proposed
11 legislation to the speaker of the house of representatives, the president of the senate, the house
12 clerk, the senate clerk, the governor, and the state library on or before November 1, 2026.

13 2 Prospective Repeal. RSA 19-A:14, relative to the commission to study the economic impact of
14 the arts and culture in New Hampshire, is repealed.

15 3 Effective Date.

16 I. Section 2 of this act shall take effect November 1, 2026.

17 II. The remainder of this act shall take effect upon its passage.
