HOUSE BILL **1348**

AN ACT relative to possession of human remains for law enforcement training purposes.

ANALYSIS

This bill authorizes law enforcement to possess human remains, upon written consent, for the purpose of training cadaver dogs.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty-Six

AN ACT relative to possession of human remains for law enforcement training purposes.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Purpose. This chapter establishes the legal framework under which law enforcement agencies
2 in the state of New Hampshire may possess portions of human remains for the sole purpose of
3 training cadaver detection canines, while ensuring compliance with ethical standards and respect for
4 the deceased.

5 2 New Chapter; Possession of Human Remains for Law Enforcement Purposes. Amend RSA by
6 inserting after chapter 291-A the following new chapter:

7 CHAPTER 291-B

8 POSSESSION OF HUMAN REMAINS FOR LAW ENFORCEMENT PURPOSES

9 291-B:1 Definitions.

10 As used in this chapter:

11 I. "Cadaver canine" means a dog trained to detect the scent of human remains for law
12 enforcement purposes.

13 II. "Portions of human remains" shall mean identifiable human tissue, bone, or other
14 anatomical material derived from a deceased individual.

15 291-B:2 Authorization and Consent to Possess Human Remains for Law Enforcement Training.

16 I. Law enforcement agencies may possess portions of human remains for cadaver canine
17 training only under the following conditions:

18 (a) Written consent is obtained from:

19 (1) The next of kin or legal representative of the deceased; or

20 (2) The deceased individual, prior to death, through a legally valid document
21 expressing their intent to donate their body or portions thereof for scientific or law enforcement
22 training purposes.

23 (b) The consent explicitly authorizes the use of the remains for training purposes and
24 identifies the specific portions to be used.

25 III. The written consent shall be maintained by both the law enforcement agency and the
26 funeral home or mortuary involved. Such documentation shall be made available for inspection by
27 the law enforcement agency or other regulatory authorities upon request.

28 291-B:3 Conduct During Possession of Human Remains; Return.

29 I. Upon completion of training, all remaining portions of the human remains shall be
30 returned to the designated funeral home or mortuary.

1 II. The funeral home or mortuary shall ensure the proper and lawful disposition of the
2 remains in accordance with RSA 290 and other applicable laws.

3 291-B:4 Oversight.

4 I. The department of safety shall adopt rules establishing protocols to ensure respectful
5 handling and secure storage of human remains.

6 II. The department of safety may conduct periodic audits of law enforcement agencies to
7 ensure compliance with this section.

8 III. Any violation of this section or any rules or procedures adopted pursuant to this section
9 may result in disciplinary action, revocation of authorization, or other penalties as prescribed by law.

10 3 Effective Date. This act shall take effect 60 days after its passage.
