SENATE BILL **622-FN**

AN ACT relative to the offense of identity fraud.

ANALYSIS

This bill adds a definition of entity and explicitly includes entities in the prohibited conduct for the offense of identity fraud.

AN ACT relative to the offense of identity fraud.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Identity Fraud; Definitions. Amend RSA 638:25 to read as follows:

2 638:25 Definitions.

3 In this subdivision:

4 I. **"Entity" means any corporation, limited liability company, trust, partnership,**
5 **incorporated or unincorporated association or organization, and any other legal entity or**
6 **combination of entities, including any state, county, or municipal government and any**
7 **subdivision, branch, department, or agency thereof.**

8 II. "Personal identifying information" means any name, number, or information that may be
9 used, alone or in conjunction with any other information, to assume the identity of an individual **or**
10 **entity**, including any name, address, telephone number, driver's license number, social security
11 number, employer or place of employment, employee identification number, mother's maiden name,
12 demand deposit account number, savings account number, credit card number, debit card number,
13 personal identification number, account number, ~~[or]~~ computer password identification, **or logo or**
14 **other mark used to identify an entity.**

15 ~~[II.]~~ III. "Pose" means to falsely represent oneself, directly or indirectly, as another person
16 or persons, **or entity or entities.**

17 ~~[III.]~~ IV. "Victim" means any person **or entity** whose personal identifying information has
18 been unlawfully obtained or recorded or any person or entity that provided money, credit, goods,
19 services, or anything of value and has suffered financial loss as a direct result of the commission or
20 attempted commission of a violation of this subdivision.

21 2 Identity Fraud. Amend RSA 638:26, I to read as follows:

22 I. A person is guilty of identity fraud when the person:

23 (a) Poses as another person **or entity** with the purpose to defraud in order to obtain
24 money, credit, goods, services, or anything else of value;

25 (b) Obtains, ~~[or]~~ records, **or uses** personal identifying information about another person
26 **or entity** without the express authorization of such person **or entity**, with the intent to pose as such
27 person **or entity**;

28 (c) Obtains, ~~[or]~~ records, **or uses** personal identifying information about a person **or**
29 **entity** without the express authorization of such person **or entity** in order to assist another to pose
30 as such person **or entity**; or

1 (d) Poses as another person ***or entity***, without the express authorization of such person
2 ***or entity***, with the purpose of obtaining confidential information about such person ***or entity, or***
3 ***another person or entity***, that is not available to the general public.

4 3 Effective Date. This act shall take effect January 1, 2027.
