HOUSE BILL ***1571-FN-A***

AN ACT requiring the department of education to review statewide academic standards and curricula.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty-Six

AN ACT requiring the department of education to review statewide academic standards and curricula.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Paragraph; Educational Content of an Adequate Education; Decennial Revision
2 Required. Amend RSA 193-E:2-a by inserting after paragraph II-a the following new paragraph:

3 II-b. The statewide academic standards, as defined in RSA 193-E:2-a, VI(b), shall be reviewed
4 for possible revision every 10 years, beginning in June 2026. The department of education shall
5 initiate a revision of these standards, as well as the current science standards, to ensure alignment
6 with high-quality criteria that emphasize rigor, clarity, and relevance. The revised standards shall
7 reflect a coherent progression of knowledge, skills, and competencies across grade levels. The
8 development process shall include meaningful participation by students, parents, and educators,
9 consistent with the intent of RSA 193-C:1, III.

10 2 New Subparagraph; Educational Content of an Adequate Education; Curriculum and
11 Materials List Added. Amend RSA 193-E:2-a, V by inserting after subparagraph (b) the following
12 new subparagraphs:

13 (c) The department shall make available a list of high quality curriculum and
14 instructional materials based upon the revised standards from which school districts may select new
15 curriculum and materials.

16 (d) The state shall revise the statewide education improvement and assessment
17 program, as established in RSA 193-C, to align with the revised standards developed pursuant to
18 RSA 193-E:2-a, II-b.

19 3 Effective Date. This act shall take effect July 1, 2027.

METHODOLOGY:

This bill, effective July 1, 2027, requires the Department of Education to review statewide academic standards for possible revision every 10 years, including revising current science standards to ensure greater rigor, clarity, relevance, and progression of knowledge across grade levels. The bill also requires the Department to make available a list of high-quality curriculum and instructional materials aligned with the revised standards (from which districts may choose) and to update the statewide education improvement and assessment program to align with the revised standards.

To estimate the fiscal impact of this bill, the Department reviewed prior costs associated with statewide academic standards revisions, prevailing market rates for contracted content-area experts, and typical expenditures related to stakeholder engagement, publication and dissemination, assessment alignment, and high-quality instructional materials (HQIM) review and vetting. The Department also considered anticipated costs associated with hiring or filling Department staff positions necessary to support this work. Estimated costs were assigned by fiscal year based on when required activities would reasonably occur during implementation, recognizing that these activities will span the 10-year revision cycle.

The Department estimates it would need the following positions to implement this bill:

- One (1) Instructional Coordinator III – Science including Engineering and technologies, and Computer Science
- One (1) Instructional Coordinator III – Social Studies including civics, history, Holocaust, and genocide education
- One (1) Instructional Coordinator III – Arts Education & World Languages
- One (1) Instructional Coordinator III – Health, Wellness & Physical Education
