AN ACT enabling the division of motor vehicles to create a temporary traditional driver's license for youth operators about to turn 21 and relative to fleet vehicle registration requirements.

STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Twenty-Six*

AN ACT enabling the division of motor vehicles to create a temporary traditional driver's license for youth operators about to turn 21 and relative to fleet vehicle registration requirements.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1 1 New Paragraph; Temporary Licenses for Drivers Turning 21. Amend RSA 263:10 by inserting  
2 after paragraph II the following new paragraph:

3 III. Notwithstanding paragraphs I and II, the director may issue temporary licenses to  
4 youth operators who are transitioning pursuant to RSA 263:14 to operators' licenses, up to 30 days  
5 prior to their twenty-first birthday, provided that the physical license is delivered only on or after  
6 their twenty-first birthday. This temporary license shall be valid for driving purposes only until the  
7 new license is issued, and it shall remain valid for up to 60 days after the expiration of the youth  
8 operator's license. For all online renewals, a transaction receipt issued upon renewal through the  
9 division of motor vehicles website, when accompanied by the existing driver's license, shall serve as  
10 the temporary license and proof of renewal.

11 2 New Paragraph; Certificates of Title and Registration of Vehicles; Fees to be Collected.  
12 Amend RSA 261:141 by inserting after paragraph VI the following new paragraph:

13 VI-a. If a vehicle is to be registered in accordance with RSA 261:40-b, the following shall  
14 apply:

15 (a) If an original registration, the month in which the anniversary of the owner's birth  
16 occurs will be one of the next 2 or 3 months, the fee shall be increased by 1/24 for each whole month  
17 or part thereof remaining until the end of the month in which such anniversary will occur.

18 (b) If a vehicle has been previously registered pursuant to RSA 261:40-b, said vehicle  
19 registration shall not be renewed for less than a 24 month fee, provided that the renewal registration  
20 is effected within 24 months of the expiration of the registrant's last valid registration. If a vehicle  
21 has been previously registered, and the owner of said vehicle fails to renew the vehicle registration  
22 in the month said renewal was legally required to be made when said renewal is obtained within 24  
23 months of the last valid registration, the 24 month renewal fees charged hereunder shall be  
24 computed at the applicable mill rate which applied in the month when the vehicle should have been  
25 legally registered. If the registration is renewed beyond the 24 months immediately succeeding the  
26 last valid registration, the 24 month fee charged shall be computed at the mill rate applicable on the  
27 date when any successive registration period would have begun, and the minimum fee in such cases  
28 shall be for 24 months, except in those cases where the registrant can demonstrate to the  
29 satisfaction of the director that the vehicle has not been operated since the expiration of the last

1 valid registration, in which case the registrant may register at the applicable mill rate on the date of  
2 the registration.

3 3 New Paragraph; Certificates of Title and Registration of Vehicles; Fees for Registration  
4 Permits. Amend RSA 261:153 by inserting after paragraph III the following new paragraph:

5 III-a. If a vehicle is to be registered in accordance with RSA 261:40-b, the following shall  
6 apply:

7 (a) If the month in which the anniversary of the owner's birth occurs will be one of the  
8 next 2 or 3 months, the permit fee shall be increased by 1/24 for each whole month or part thereof  
9 remaining until the end of the month in which such anniversary will occur and the owner shall not  
10 be required to obtain a permit for the next registration period.

11 (b) In all other cases for vehicles specified in RSA 261:40-b, the permit fee shall be  
12 determined by multiplying 1/24 of the permit fee for the vehicle times the total number of whole  
13 months and any part of a month remaining until the end of the month in which the anniversary of  
14 the owner's birth occurs, and the owner shall be required to obtain a permit for the next registration  
15 period.

16 4 Effective Date.

17 I. Section 1 of this act shall take effect July 1, 2026.

18 II. The remainder of this act shall take effect upon its passage.

**METHODOLOGY:**

This bill allows for the creation of a temporary traditional driver's license for youth operators whose youth operator license will expire in 30 days or less. The Department of Safety states this would require changes to two different systems at a one-time estimated cost of \$48,000 to make these changes (240 development, testing and implementation hours @ \$200 per hour).

The Department states sections 2 and 3 of this bill, relative to vehicle registration changes, will have no impact on revenue or expenditures.
