permitting excused absences for student participation in certain activities and mandating the state board of education to grant school reassignment requests for students demonstrating a manifest educational hardship.

AMENDED ANALYSIS

This bill:

I. Permits excused absences for students that are participating in civic engagement activities and career or technical education (CTE) activities so long as parental notice is provided to schools and other requirements are met.

II. Directs the state board of education to develop rules, a list of recognized CTE organizations, and alternative academic credits relative to participation in civic or CTE activities.

III. Mandates that the state board of education, on appeal, grant a parent's or guardian's request to re-assign their student to another public school, public academy, or an approved private school where such parent or guardian demonstrates the student has a manifest educational hardship.

IV. Adds a statutory cross-reference to the exceptions for legal residence requirements relative to school attendance.

In the Year of Our Lord Two Thousand Twenty-Six

AN ACT permitting excused absences for student participation in certain activities and mandating the state board of education to grant school reassignment requests for students demonstrating a manifest educational hardship.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 307:1 New Section; Excused Absences for Civic and Career Technical Education Activities. Amend
2 RSA 193 by inserting after section 1-c the following new section:

3 193:1-d Excused Absences for Civic and Career Technical Education Activities.

4 I. Students in public or public charter primary or secondary schools who wish to attend civic
5 events during the school day shall have their school absences excused.

6 II. For the purposes of this section:

7 (a) "Civic event" means:

8 (1) Any event, activity, hearing, or meeting held by a federal, state, county, or local
9 government office, agency, or body; or

10 (2) Any educational program, competition, or award ceremony sponsored or hosted by a
11 patriotic or national organization, listed in 36 U.S.C., subtitle II, part B.

12 (b) "Career or technical education event," or "CTE event," means:

13 (1) State, regional, or national competitions or conferences sponsored by CTE student
14 organizations recognized by the state board of education pursuant to RSA 186:11, XXXVIII;

15 (2) Agricultural fairs where students are exhibiting livestock or project work; or

16 (3) Individual job shadows or workplace observations of no more than one school day per
17 employer.

18 III. Schools shall be required to excuse 2 of a student's school day absences per academic year
19 for civic or CTE events.

20 (a) This paragraph shall not preclude schools from excusing further absences at their own
21 discretion.

22 (b) Participation in activities related to statutory or executive New Hampshire youth advisory
23 councils, either as a member or a guest, shall supersede this paragraph and shall always be excused.

4 participation in to verify the justification of the absence. Such evidence may include:

5 (a) A form created by the school and signed by an official of the activity, such as a New

7 (b) A letter of excusal signed by a government or event official.

24 307:3 New Subparagraph; Change of School or Assignment; Best Interest of Student; Manifest
25 Educational Hardship; Procedure for Appeals Modified. Amend RSA 193:3, II by inserting after
26 subparagraph (g) the following new subparagraphs:

27 (1) Pursuant to this subparagraph, if the state board of education finds that the student
28 has a manifest educational hardship, the state board of education shall grant the parent's or guardian's
29 request to re-assign the student to another public school, public academy, or an approved private school
30 within the district, or to a public school, public academy, or an approved private school in another district.

31 (2) The student shall be enrolled in the receiving public school, public academy, or
32 approved private school, subject only to the limitations set forth in RSA 193:3, III-a(d) and the admission
33 requirements described in RSA 193:3, III-a(f).

34 307:4 School Attendance; Legal Residence Required; Exceptions; Cross-Reference Added. Amend
35 RSA 193:12, I to read as follows:

36 I. Notwithstanding any other provision of law, no person shall attend school, or send a pupil to the
37 school, in any district of which the pupil is not a legal resident, without the consent of the district or of the
38 school board except as otherwise provided in this section, ***RSA 193:3***, or ~~[in]~~ RSA 193:28.

17 1448 of the 2026 regular legislative session does not become law, sections 1 and 2 of this act shall take
18 effect upon its passage and sections 5 and 6 of this act shall not take effect.

19 307:8 Effective Date.

20 I. Sections 1, 2, 5, and 6 of this act shall take effect as provide in section 7 of this act.

II. The remainder of this act shall take effect upon its passage.
