ANALYSIS

This bill:

- I. Defines new categories of dedicated funds.
- II. Restructures the placement of dedicated funds within the chapter.
- III. Repeals outdated fund references and clarifies certain categories of funds.

The bill is a request of the state treasurer and state comptroller.

STATE OF NEW HAMPSHIRE

AN ACT relative to state funds.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1 1 State Treasurer and State Accounts; Application of Receipts. Amend the introductory  
2 paragraph of RSA 6:12, I(b) to read as follows:

3 (b) Moneys received by the state treasurer, as provided in RSA 6:11, shall be accounted  
4 for in the state's accounting system as general revenue of the state, with the exception of the  
5 following dedicated funds or accounts:

6 (1a) ***Funds received pursuant to RSA 6:12-b, which shall be maintained***  
7 ***pursuant to the provisions of RSA 6:12-b.***

8 (1b) ***Funds received pursuant to RSA 6:12-c, which shall be maintained***  
9 ***under the terms of the referenced trust, permanent or endowment fund.***

10 (1c) ***Funds received pursuant to RSA 6:12-d, which shall be maintained***  
11 ***under the terms of the referenced custodial or escrow account.***

12 2 New Subparagraphs; State Treasurer and State Accounts; Application of Receipts. Amend  
13 RSA 6:12, I(b) by inserting after subparagraph (399) the following new subparagraphs:

14 (400) Moneys deposited in the water resources project accounts of the department of  
15 environmental services established in RSA 482-A:3, III.

16 (401) Moneys deposited in the drinking water groundwater trust fund established in  
17 RSA 6-D:1.

18 (402) Moneys deposited in the fox forest trust funds account of the department of  
19 natural and cultural resources.

20 3 State Treasurer and State Accounts; Application of Receipts. Amend RSA 6:12, III(i) to read  
21 as follows:

22 (i) "Custodial fund or account" means moneys or other assets owned by a person or  
23 entity but which are entrusted to and controlled by another, the custodian. The role of the custodian  
24 includes, but is not limited to, holding such moneys or other assets in safekeeping, arranging for the  
25 settlement of any purchases or sales of such assets, collecting income from investments, and  
26 providing information to the owners of such moneys or other assets. ***The state, as a holder of***  
27 ***these assets, acts in a fiduciary capacity, agrees to remit the assets, income from the assets,***  
28 ***or both, to a specified beneficiary at a specified time.***

29 4 State Treasurer and State Accounts; Trust and Agency Funds. Amend the title of RSA 6:12-c  
30 to read as follows:

31 6:12-c Trust, ***Permanent***, and ***Endowment*** [Agency] Funds.

14          (s) The Connecticut lakes headwaters tract road maintenance endowment fund under

16          (t) The Guy Thompson account of the New Hampshire veterans' home.

17          (u) The youth development center trust funds.

18           6 New Subparagraphs; State Treasurer and State Accounts; Custodial and Escrow Accounts.  
19 Amend RSA 6:12-d, II by inserting after subparagraph (m) the following new subparagraphs:

20          (n) The private postsecondary career school deposit accounts pursuant to RSA 188-G:3,  
21 IV(b).

22          (o) The yellow transportation escrow account of the department of labor.

23          (p) The crown paper workers compensation escrow account of the department of labor.

24          (q) The electric assistance program fund established in RSA 6:12-b.

25           7 State Treasurer and State Accounts; Reporting Requirements for Dedicated Funds. Amend  
26 the introductory paragraph of RSA 6:12-e to read as follows:

27           6:12-e Reporting Requirements for Dedicated Funds. The definitions established in RSA 6:12  
28 shall apply to this section. The administrator of each fund, account, or trust listed in RSA 6:12, RSA  
29 6:12-b, RSA 6:12-c, and RSA 6:12-d shall complete and file an annual report with the commissioner  
30 of administrative services on or before [~~September~~] **October** 15 of each fiscal year, covering the most  
31 recently ended fiscal year. The commissioner of administrative services shall compile these reports  
32 into a document known as the annual compilation of dedicated funds report on or before November  
33 15 of each year and forward it to the governor, the president of the senate, the speaker of the house  
34 of representatives, the legislative budget assistant, and the relevant legislative policy committees of  
35 the house and senate as indicated on said reports by the administrator of each fund, account, or  
36 trust. The compilation shall be made available in a searchable electronic format and an extractable

1 modified version shall be available for sorting. Each annual report shall be retained in the office of  
2 the state comptroller and made available as requested, and shall include, but not be limited to:

4 Amend RSA 6:12-f, II (b) to read as follows:

5 (b) Submitting a request to the state treasurer to open and separately manage a new  
6 trust, **permanent or endowment** ~~[and agency]~~ fund, pursuant to RSA 6:12-c, or a new custodial **or**  
7 ~~[and]~~ escrow account, pursuant to RSA 6:12-d.

23 XI. RSA 6:12, I(b)(221), relative to moneys deposited in the Connecticut Lakes headwaters  
24 tract road maintenance endowment fund.

25 XII. RSA 6:12, III(h), relative to the definition of an agency fund.

26 XIII. RSA 6:12-c, II(a), relative to the Caroline A. Fox fund.

27 XIV. RSA 6:12-d, II(c), relative to the special fund for active cases account.

28 XV. RSA 6:12-d, II(e), relative to the dissolution of corporation account.

29 XVI. RSA 6:12-d, II(h), relative to the Guy Thompson account.

30 XVII. RSA 6:12-d, II(j), relative to the water resources project accounts.

31 XVIII. RSA 6:12-d, II(l), relative to the racing and charitable gaming escrow account.

32 10 Effective Date. This act shall take effect 60 days after its passage.
