

Amendment to HB 1280-FN

1 Amend the title of the bill by replacing it with the following:

2

3 AN ACT relative to copayments for insulin, establishing a wholesale prescription drug
4 importation program, establishing a New Hampshire prescription drug affordability
5 board, establishing the prescription drug competitive marketplace, relative to the
6 pricing of generic prescription drugs, relative to prior authorization for prescription
7 drug coverage, and requiring insurance coverage for epinephrine auto-injectors.
8

9 Amend the bill by replacing all after the enacting clause with the following:

11 1 Accident and Health Insurance; Coverage for Diabetes Services and Supplies; Individual.

12 Amend RSA 415:6-e to read as follows:

13 415:6-e Coverage for Diabetes Services and Supplies. Each insurer that issues or renews any
14 individual policy, plan, or contract of accident or health insurance providing benefits for medical or
15 hospital expenses, shall provide to certificate holders of such insurance, who are residents of this
16 state, coverage for medically appropriate and necessary outpatient self-management training and
17 educational services, pursuant to a written order of a primary care physician or practitioner,
18 including but not limited to medical nutrition therapy for the treatment of diabetes, provided by a
19 certified, registered, or licensed health care professional with expertise in diabetes, subject to the
20 terms and conditions of the policy. Each insurer that issues or renews any individual policy, plan, or
21 contract of accident or health insurance providing benefits for medical or hospital expenses which
22 provides a prescription rider shall cover medically appropriate or necessary insulin, oral agents, and
23 equipment used to treat diabetes subject to the terms and conditions of the policy. ***Each insurer***
24 ***that provides coverage for prescription insulin drugs shall cap the total amount that a***
25 ***covered person is required to pay for each covered insulin drug prescription at an amount***
26 ***not to exceed \$30 for each 30-day supply of each insulin prescription. The maximum \$30***
27 ***copayment for each 30-day supply of each covered insulin drug prescription shall apply***
28 ***when an original prescription is dispensed as well as when refills of the prescription are***
29 ***dispensed, including early refills. Coverage for prescription insulin drugs shall not be***
30 ***subject to any deductible.*** Each insurer that issues or renews any individual policy, plan, or
31 contract of accident or health insurance providing benefits for medical or hospital expenses which
32 provides for durable medical equipment coverage shall provide coverage for medically appropriate or
33 necessary equipment used to treat diabetes subject to the terms and conditions of the policy.

2 RSA 415:18-f to read as follows:

3 415:18-f Coverage for Diabetes Services and Supplies. Each insurer that issues or renews any
4 policy, plan, or contract of group accident or health insurance providing benefits for medical or
5 hospital expenses, shall provide each group, or to the portion of each group comprised of certificate
6 holders of such insurance who are residents of this state, coverage for medically appropriate and
7 necessary outpatient self-management training and educational services, pursuant to a written
8 order of a primary care physician or practitioner, including but not limited to medical nutrition
9 therapy for the treatment of diabetes, provided by a certified, registered, or licensed health care
10 professional with expertise in diabetes, subject to the terms and conditions of the policy. Each
11 insurer that issues or renews any group policy, plan, or contract of accident or health insurance
12 providing benefits for medical or hospital expenses which provides a prescription rider shall cover
13 medically appropriate or necessary insulin, oral agents, and equipment used to treat diabetes subject
14 to the terms and conditions of the policy. ***Each insurer that provides coverage for prescription***
15 ***insulin drugs shall cap the total amount that a covered person is required to pay for each***

25 3 Health Service Corporations; Coverage for Diabetes Services and Supplies. Amend RSA 420-
26 A:17-a to read as follows:

27 420-A:17-a Coverage for Diabetes Services and Supplies. Every health service corporation and
28 every similar corporation licensed under the laws of another state that issues or renews any policy,
29 plan, or contract of individual or group accident or health insurance providing benefits for medical or
30 hospital expenses, shall provide to each individual or group, or to the portion of each group
31 comprised of certificate holders of such insurance who are residents of this state, coverage for the
32 medically appropriate and necessary outpatient self-management training and educational services,
33 pursuant to a written order of a primary care physician or practitioner, including but not limited to
34 medical nutrition therapy for the treatment of diabetes, provided by a certified, registered, or
35 licensed health care professional with expertise in diabetes, subject to the terms and conditions of
36 the policy. Each health service corporation that issues or renews any individual or group policy,
37 plan, or contract of accident or health insurance providing benefits for medical or hospital expenses

15 RSA 420-B:8-k to read as follows:

16 420-B:8-k Coverage for Diabetes Services and Supplies. Every health maintenance organization
17 and every similar corporation licensed under the laws of another state that issues or renews any
18 policy, plan, or contract of individual or group health insurance providing benefits for medical or
19 hospital expenses, shall provide to each individual or group, or to the portion of each group
20 comprised of certificate holders of such insurance who are residents of this state, coverage for the
21 medically appropriate and necessary outpatient self-management training and educational services,
22 pursuant to a written order of a primary care physician or practitioner, including but not limited to
23 medical nutrition therapy for the treatment of diabetes, provided by a certified, registered, or
24 licensed health care professional with expertise in diabetes, subject to the terms and conditions of
25 the policy. Each health maintenance organization that issues or renews any individual or group
26 policy, plan, or contract of accident or health insurance providing benefits for medical or hospital
27 expenses which provides a prescription rider shall cover medically appropriate or necessary insulin,

3 5 New Chapter; Prescription Drug Affordability Board. Amend RSA by inserting after chapter
4 126-AA the following new chapter:

5 CHAPTER 126-BB

6 NEW HAMPSHIRE PRESCRIPTION DRUG AFFORDABILITY BOARD

7 126-BB:1 Definitions. In this chapter:

8 I. "Board" means the New Hampshire prescription drug affordability board.

9 II. "Brand-name drug" means a prescription drug marketed under a proprietary name or
10 registered trademark name, including a biological product.

11 III. "Generic drug" means a prescription drug, whether identified by its chemical,
12 proprietary, or nonproprietary name, that is not a brand-name drug and is therapeutically
13 equivalent to a brand-name drug in dosage, safety, strength, method of consumption, quality,
14 performance, and intended use. "Generic drug" includes a biosimilar product.

15 IV. "Manufacturer" means a manufacturer of prescription drugs that are distributed in the
16 state. A manufacturer excludes a packager, repackager, labeler, and relabeler.

17 V. "Pricing unit" means the smallest dispensable amount of a prescription drug that could
18 be dispensed.

19 VI. "Public payor" means any division of state, county, or municipal government that
20 administers a health plan for its employees or an association of state, county, or municipal
21 employers that administers a health plan for its employees.

22 VII. "Wholesale acquisition cost" means a manufacturer's listed price for sale to a wholesale
23 drug distributor or other entity that purchases a prescription drug directly from the manufacturer,
24 not including any price concessions.

25 126-BB:2 New Hampshire Prescription Drug Affordability Board Established. There is
26 established the New Hampshire prescription drug affordability board to carry out the purposes of
27 this chapter.

28 I. The board shall consist of 5 members with expertise in health care economics or clinical
29 medicine, who shall not be, or be directly related to, anyone affiliated with, employed by, or
30 representing the interests of a public payor, pharmaceutical or pharmacy company, pharmacy
31 benefits management company, or health insurance provider and who have completed a conflict of
32 interest statement. They shall be appointed as follows:

33 (a) Two members by the president of the senate. The president of the senate shall also
34 appoint one alternate board member who will participate in deliberations of the board in the event a
35 member appointed by the president of the senate elects to be recused as provided in RSA 126-BB:3.

36 (b) Two members by the speaker of the house of representatives. The speaker of the
37 house of representatives shall also appoint one alternate board member who will participate in

1 deliberations of the board in the event a member appointed by the speaker of the house of
2 representatives elects to be recused as provided in RSA 126-BB:3.

3 (c) One member by the governor. The governor shall also appoint one alternate board
4 member who shall participate in deliberations of the board in the event the member appointed by
5 the governor elects to be recused as provided in RSA 126-BB:3.

6 II. Members shall be appointed to 5-year terms. Of the initial appointees, the member
7 appointed by the governor shall serve an initial term of 5 years, one member appointed by the
8 president of the senate and one member appointed by the speaker of the house of representatives
9 shall serve an initial term of 4 years and one member appointed by the president of the senate and
10 one member appointed by the speaker of the house of representatives shall serve an initial term of 3
11 years.

12 III. A majority of board members shall constitute a quorum.

13 IV. The chair of the board shall be elected by an affirmative vote of at least 4 of the 5
14 members of the board.

15 V. Beginning no later than March 1, 2021, the board shall meet in public session at least
16 every 12 weeks to review prescription drug information and to make recommendations pursuant to
17 RSA 126-BB:5. The first meeting shall be called by the first-named appointee of the senate
18 president.

19 (a) Each public meeting shall be announced 2 weeks in advance, and materials for the
20 meeting shall be made public at least one week in advance.

21 (b) Each public meeting shall provide opportunity for comment from the public in
22 attendance at the meeting, and the board shall provide the opportunity for the public to submit
23 written comments on pending decisions.

24 (c) The board may allow expert testimony at public meetings and any meeting conducted
25 in executive session as permitted by subparagraph (d).

26 (d) Notwithstanding requirements of RSA 91-A, the board may meet in executive
27 session, except that any decision of the board shall be made in public.

28 VI. The board shall be administratively attached to the department of health and human
29 services. The board may employ an executive director who shall be a classified employee.

30 126-BB:3 Conflicts of Interest. The following provisions govern any conflict of interest for a
31 member of the board, a member of the advisory council established in RSA 126-BB:4 or any staff
32 member or contractor of the board.

33 I. When appointing a member of the board or the advisory council, the appointing authority
34 shall consider any conflict of interest disclosed by the prospective member. A member shall elect to
35 be recused from any board activity in the case in which the member or an immediate family member
36 of the member has a conflict of interest. For the purposes of this paragraph, "conflict of interest"
37 means an association, including a financial or personal association, that has the potential to bias or

1 have the appearance of biasing an individual's decisions in matters related to the board or the
2 conduct of the board's activities.

3 II. A board member or staff or contractor of the board with a conflict of interest shall elect to
4 be recused. For purposes of this paragraph, "conflict of interest" means any instance in which a
5 member of the board or an immediate family member of the member has received or could receive
6 either of the following:

7 (a) A direct financial benefit of any amount deriving from the results or findings of a
8 study or determination by or for the board; or

9 (b) A financial benefit from individuals or companies that own or manufacture
10 prescription drugs, services, or items to be studied by the board that in the aggregate exceeds \$5,000
11 per year. For purposes of this subparagraph, "financial benefit" includes honoraria, fees, stock, or
12 other financial benefit and the current value of the member's or immediate family member's already
13 existing stock holdings, in addition to any direct financial benefit deriving from the results or
14 findings conducted under this section.

15 (c) A conflict of interest shall be disclosed in the following manner:

16 (1) By the board in the employment of board senior staff.

17 (2) By the governor, president of the senate, or speaker of the house of
18 representatives when appointing members to the board and advisory council.

19 (3) By the board in describing any recusals as part of any final decision relating to a
20 prescription drug.

21 (4) By the 5th day after a conflict is identified or, if a public meeting of the board will
22 occur within that 5-day period, in advance of the public meeting.

23 (d) Conflicts of interest shall be publicly posted on the website of the board. The
24 information disclosed shall include the type, nature, and magnitude of the interests of the individual
25 involved, except to the extent that the individual elects to be recused from participation in any
26 activity with respect to which the potential conflict exists.

27 (e) The board, the advisory council, a member of the board or staff, or a contractor of the
28 board may not accept gifts, bequests, or donations of services or property that suggest a conflict of
29 interest or have the appearance of creating bias in the work of the board or advisory council.

30 (f) A member of the advisory council who accepts a gift, bequest, or donation of services
31 or property that suggests a conflict of interest or has the appearance of creating bias in the work of
32 the advisory council shall disclose the gift, bequest, or donation publicly.

33 126-BB:4 Advisory Council. A 12-member advisory council is established to advise the board on
34 establishing annual spending targets pursuant to RSA 126-BB:5, I and determining methods for
35 meeting those spending targets pursuant to RSA 126-BB:5, III. The advisory council shall consist of
36 the following members:

37 I. The governor, or designee.

- 10 X. The chancellor of the university system of New Hampshire, or designee.
- 11 XI. The chancellor of the New Hampshire community college system, or designee.
- 12 XII. A representative of consumer interests, appointed by the governor, who shall serve a 3-
- 13 year term.

14 126-BB:5 Powers and Duties of the Board. The board has the following powers and duties:

15 I.(a) Beginning with the year 2022 and in consultation with the advisory council, the board
16 shall identify strategies that optimize spending by public payors for pharmaceutical products while
17 reasonably ensuring subscriber access to needed pharmaceutical products. To achieve this goal, the
18 board shall determine annual spending targets for prescription drugs purchased by public payors
19 based upon a 10-year rolling average of the medical care services component of the United States
20 Department of Labor, Bureau of Labor Statistics Consumer Price Index, medical care services index,
21 plus a reasonable percentage for inflation and minus a spending target for pharmacy savings as
22 determined by the board.

23 (b) The board shall determine spending targets on specific prescription drugs that may
24 cause affordability challenges to enrollees in a public payor health plan. Such targets shall consider
25 any medical cost offsets achieved by utilization of the drug.

26 (c) The board shall determine which public payors are likely to exceed the spending
27 targets determined under subparagraph (a).

28 II. The board may consider the following data to accomplish its duties under this section:

29 (a) A public payor's prescription drug spending data, which the 3rd-party administrator
30 or insurer for the public payor's health plan shall provide to the board on behalf of the public payor
31 upon request notwithstanding any provision of law to the contrary, including:

32 (1) Expenditures and utilization data for prescription drugs for each plan offered by
33 a public payor.

34 (2) The formulary for each plan offered by a public payor and prescription drugs
35 common to each formulary.

36 (3) Pharmacy benefit management services and other administrative expenses of the
37 prescription drug benefit for each plan offered by a public payor.

1 (4) Enrollee cost sharing for each plan offered by a public payor.

2 (5) Aggregate net spending on the prescription drug benefit.

3 (b) Data compiled by the department of health and human services. Prescription drug
4 spending data provided to the board under this subparagraph is confidential to the same extent it is
5 confidential while in the custody of the entity that provided the data to the board.

6 III. Based upon the prescription drug spending data received under paragraph II, the board,
7 in consultation with a representative of each public payor shall determine methods for the public
8 payor to meet the spending targets established under paragraph I. While continuing to ensure
9 adequate access by subscribers to needed prescribed pharmaceutical products, the board shall
10 determine whether the following methods reduce costs to individuals purchasing prescription drugs
11 through a public payor and allow public payors to meet the spending targets established under
12 paragraph I:

13 (a) Negotiating specific rebate amounts on the prescription drugs that contribute most to
14 spending that exceeds the spending targets.

15 (b) Changing a formulary when sufficient rebates cannot be secured under
16 subparagraph (a).

17 (c) Establishing a common prescription drug formulary for all public payors.

18 (d) Prohibiting health insurance carriers in the state administering benefits for a public
19 payor from offering on their formularies prescription drugs when the method described in
20 subparagraph (b) is implemented.

21 (e) Purchasing prescription drugs in bulk or through a single purchasing agreement for
22 use among public payors.

23 (f) Collaborating with other states and state prescription drug purchasing consortia to
24 purchase prescription drugs in bulk or to jointly negotiate rebates.

25 (g) Allowing health insurance carriers providing coverage to small businesses and
26 individuals in the state to participate in the public payor prescription drug benefit for a fee.

27 (h) Procuring common expert services for public payor, including but not limited to
28 pharmacy benefit management services and actuarial services.

29 IV. By November 1, 2020 and annually thereafter, the board shall report its
30 recommendations, including prescription drug spending targets, their strategies for optimization of
31 affordability of prescription drugs for the state and all of its residents, the progress of implementing
32 those recommendations, as well as the annual net spending by public payors on prescription
33 pharmaceutical products as a measure of the efficacy of implementation of those recommendations to
34 date, to the standing committees of the general court with jurisdiction over health coverage and
35 insurance matters and to the governor. This report shall also contain the following information
36 about prescription drugs, both brand name and generic:

37 (a) The 25 most frequently prescribed drugs in the state;

1 (b) The 25 costliest drugs as determined by the total amount spent on those drugs in the
2 state; and

3 (c) The 25 drugs with the highest year-over-year cost increases as determined by the
4 total amount spent on those drugs in the state.

5 V. The board may apply for and receive funds, grants, or contracts from public and private
6 sources.

7 126-BB:6 Rulemaking. The board shall adopt rules under RSA 541-A for the following:

8 I. Procedures for drug price transparency as required under RSA 126-BB:7.

9 II. The adoption of all fees under RSA 126-BB:8.

10 III. Proceedings for assessing civil fines under RSA 126-BB:10.

11 IV. Any other matter required to implement this chapter.

12 126-BB:7 Drug Price Transparency; Non-disclosure Requirements.

13 I. The board shall develop and implement policies and procedures for its collection,
14 processing, storage, and analysis of clinical, financial, quality restructuring and prescription drug
15 price data for the following purposes:

16 (a) To use, build, and improve upon and coordinate existing data sources and
17 measurement efforts through the integration of data systems and standardization of concepts.

18 (b) To coordinate the development of a linked public and private sector information
19 system.

20 (c) To emphasize data that is useful, relevant, and not duplicative of existing data.

21 (d) To minimize the burden on those providing data.

22 (e) To preserve the reliability, accuracy, and integrity of collected data.

23 II. The board shall adopt rules to ensure that:

24 (a) Payors, providers, prescription drug manufacturers, wholesale drug distributors, and
25 pharmacy benefits managers file data as required by RSA 126-BB:9.

26 (b) Users that obtain health data and information from the board safeguard the
27 identification of patients and health care practitioners.

28 (c) Payors, providers, prescription drug manufacturers, wholesale drug distributors, and
29 pharmacy benefits managers pay all assessments as required by RSA 126-BB:8.

30 (d)(1) Only the board and employees assigned to the board may access the information
31 received pursuant to this chapter and only for purpose of effectuating the powers and duties granted
32 the board by this chapter. The board shall limit access to any information that it receives pursuant
33 to this chapter to the smallest number of employees and other personnel possible; and all such
34 individuals shall, as a condition of employment, be required to execute non-disclosure agreements
35 under which they are restricted from disclosing any information they may receive in connection with
36 this chapter during their employment term and in perpetuity post-employment.

1 (2) If the board, its members, employees, or personnel willfully shares or discloses
2 for unauthorized purposes information that is trade secret information, confidential, commercial or
3 proprietary information, or information designated as “confidential” by the owner of the information,
4 the board or the individual who made the unauthorized disclosure may be subject to any penalties
5 available under federal and state laws, including trade secret misappropriation laws, to the extent
6 permitted by law.

7 126-BB:8 Funding; Assessment of Fees.

8 I. The expenses and cost of operation of the board shall be funded by reasonable user fees
9 and assessments determined in rules adopted by the board.

10 (a) Fees may be charged for the reasonable costs of duplicating, mailing, publishing, and
11 supplies.

12 (b) Reasonable user fees shall be charged on a sliding scale for the right to access and
13 use the health data and information available from the board. Fees may be charged for services
14 provided to the department on a contractual basis. Fees may be reduced or waived for users that
15 demonstrate a plan to use the data or information in research of general value to the public health or
16 inability to pay the scheduled fees, as provided by rules adopted by the board.

17 (c) Annual assessments of not less than \$100 assessed against the following entities:

18 (1) Health insurance carriers and health maintenance organizations on the basis of
19 the total annual health care premium.

20 (2) Third-party administrators.

21 (3) Health carriers that provide only administrative services for a plan sponsor.

22 (4) Pharmacy benefits managers that process and pay claims on the basis of claims
23 processed or paid for each plan sponsor.

24 (d) Health care policies issued for specified disease, accident, injury, hospital indemnity,
25 disability, long-term care or other limited benefit health insurance policies are not subject to
26 assessment under subparagraph (c). For purposes of this paragraph, policies issued for dental
27 services are not considered to be limited benefit health insurance policies.

28 (e) Annual assessments of not less than \$500 assessed by the board against prescription
29 drug manufacturers, wholesale drug distributors, and pharmacy benefits managers.

30 II. The aggregate level of annual assessments under subparagraphs (c) and (e) shall be an
31 amount sufficient to meet the board's expenditures authorized. The board may waive assessments
32 otherwise due under subparagraphs (c) and (e) when a waiver is determined to be in the interests of
33 the board and the parties to be assessed.

34 126-BB:9 Drug Price Notifications and Disclosures; Confidentiality; Registration.

35 I. No later than January 30, 2021 and annually thereafter, a manufacturer shall notify the
36 board when the manufacturer has during the prior calendar year:

2 percent per pricing unit;

3 (b) Increased the wholesale acquisition cost of a generic drug that costs at least \$10 per
4 pricing unit by more than 20 percent per pricing unit; or

30 outpatient prescription drug, and (ii) aggregate, company-level research and development costs and
31 such other capital expenditures that the board, in its discretion, deems relevant for the most recent
32 year for which final audited data are available.

34 section may be limited to the information and data that the pharmaceutical manufacturer includes
35 in such pharmaceutical manufacturer's annual consolidated report on Securities and Exchange

18 such participation shall comply with and shall be consistent with all applicable state and federal law
19 and requirements of ERISA.

20 VI. The state employee health plan and any self-funded public or private sector health plans
21 that may be permitted to participate with the state in a joint PBM reverse auction purchasing pool
22 shall retain full autonomy over determination of their respective prescription drug formularies and
23 pharmacy benefit designs and shall not be required to adopt a common drug formulary or common
24 prescription pharmacy benefit design. Any such entity or purchasing group shall agree, before
25 participating in the PBM reverse auction, to accept the prescription drug pricing plan that is
26 selected through the PBM reverse auction process.

27 VII. Any PBM providing services to the department or a self-funded health plan as described
28 in paragraphs IV and V, shall provide the department and the plan the complete pharmacy claims
29 data necessary to conduct the reverse auction and carry out their administrative and management
30 duties.

31 VIII. The department may adopt rules, pursuant to RSA 541-A, to implement the provisions
32 of this subdivision.

AMENDED ANALYSIS

This bill:

- I. Requires insurers to cap the total amount for insulin for covered persons.
- II. Establishes a wholesale importation program for prescription drugs from Canada by or on behalf of the state. This bill requires the department of health and human services to design the program and obtain federal approval for the program.
- III. Establishes a prescription drug affordability board to determine annual public payor spending targets for prescription drugs, develop and implement policies and procedures for the collection of prescription drug price data, implement a register of drug manufacturers for drug pricing data, and establish funding for the board by reasonable user fees and assessments.
- IV. Clarifies the pricing of generic prescription drugs under the law governing consumer protection.
- V. Clarifies the procedure for prior authorization for prescription drugs on the formulary under the managed care law.
- VI. Requires insurance coverage for epinephrine autoinjectors.
- VII. Establishes the prescription drug competitive marketplace.
