1 Amend the title of the bill by replacing it with the following:

3 AN ACT relative to allowing the ability to work from home to count toward unemployment
4 benefits eligibility and updated weekly unemployment benefit amount for total
5 unemployment and maximum total amount of benefits payable with effective dates
6 through January 1, 2027.

8 Amend the bill by replacing all after section 1 with the following:

10 2 Unemployment Compensation; Weekly Benefit Amount; Maximum Total Amount of Benefits.

11 RSA 282-A:25 is repealed and reenacted to read as follows:

12 282-A:25 Weekly Benefit Amount for Total Unemployment and Maximum Total Amount of
13 Benefits Payable During any Benefit Year. The maximum weekly benefit amount and maximum
14 benefits payable to an eligible individual, the first day of whose individual benefit year is on or after
15 the effective date of this paragraph, shall be determined by the individual's annual earnings, of
16 which in each of 2 calendar quarters the individual must have earned not less than \$1,400, as
17 follows:

5 I. In addition to RSA 281-A:25, effective January 1, 2025 the maximum weekly benefit
6 amount and maximum benefits payable to an eligible individual, the first day of whose individual
7 benefit year is on or after the effective date of this paragraph, shall be determined by the individual's
8 annual earnings, of which in each of 2 calendar quarters the individual must have earned not less
9 than \$1,400, as follows:
