HOUSE BILL **122-FN**

AN ACT relative to payment of claims arising out of actions or activities of the New Hampshire national guard.

ANALYSIS

This bill increases the maximum payment for claims arising out of actions or activities of the New Hampshire national guard from \$500 to \$1000. The bill also permits such payments for claims against the department of military affairs and veterans services.

AN ACT                   relative to payment of claims arising out of actions or activities of the New Hampshire national guard.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1           1 Department of Military Affairs and Veterans Services; Payment of Claims. Amend RSA 110-  
2 B:73 to read as follows:

3           110-B:73 Payment of Claims. The governor and council, upon the recommendation of the  
4 adjutant general, may pay claims against the state arising out of accidents occasioned by the  
5 activities of the national guard ***or arising out of claims brought against the department of***  
6 ***military affairs and veterans services***. No claim in excess of [~~\$500~~] ***\$1,000*** shall be paid to any  
7 one person, nor shall any claim be paid hereunder which is payable in whole or in part by the United  
8 States. Persons making claims hereunder shall file their applications with the adjutant general who  
9 shall investigate the circumstances and shall make a recommendation thereon to the governor and  
10 council. Any claims paid hereunder shall be a charge upon the appropriation therefor in the  
11 department of [~~the adjutant general~~] ***military affairs and veterans services***.

12           2 Effective Date. This act shall take effect 60 days after its passage.
