AN ACT extending the closing date of the OHRV trails on the Connecticut Lakes headwaters working forest property.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 New Section; Connecticut Lakes Headwaters Working Forest; OHRV Trails Closure Date.
- 2 Amend RSA 215-A by inserting after section 3-b the following new section:
- 3 215-A:3-c Connecticut Lakes Headwaters Working Forest; OHRV Trail Annual Closure Date.
- 4 Notwithstanding any conservation easement provisions or other contracts, laws, or rules to the
- 5 contrary, all existing OHRV trails on the Connecticut Lakes headwaters working forest property
- 6 shall remain open through the second Monday in October, which is Columbus Day.
- 7 2 Effective Date. This act shall take effect upon its passage.
