SENATE BILL **58-FN**

AN ACT relative to venue in criminal prosecutions of distribution of a controlled drug with death resulting.

AMENDED ANALYSIS

This bill broadens criminal venue to allow for prosecution of the crime of distribution of a controlled drug with death resulting in the jurisdiction where either the death occurred or where the manufacturing, selling, or dispensing took place.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 New Paragraph; Distribution of a Controlled Drug with Death Resulting; Venue. Amend RSA
- 2 318-B:26 by inserting after paragraph IX-a the following new paragraph:
- 3 IX-b. A prosecution for an offense under paragraph IX of this section may be commenced in
- 4 the jurisdiction where either the death occurred or the manufacturing, selling, or dispensing took
- 5 place.
- 6 2 Effective Date. This act shall take effect upon its passage.
