AN ACT relative to protection of persons from domestic violence and military protective orders.

AMENDED ANALYSIS

This bill:

I. Requires the adjutant general to provide national guard victims of sexual assault or sexual harassment financial assistance to allow the victim to participate in proceedings related to the assault or harassment.

II. Permits the introduction of military protective orders in proceedings for civil domestic violence protective orders.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Five

AN ACT relative to protection of persons from domestic violence and military protective orders.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 55:1 New Paragraph; Department of Military Affairs and Veterans Services; The Adjutant General.
2 Amend RSA 110-B:8 by inserting after paragraph IV the following new paragraph:

3 V. The adjutant general shall provide current and former members of the national guard who
4 were the victims of sexual assault or sexual harassment while members of the national guard with
5 financial assistance when the victims participate in adverse administrative proceedings or New Hampshire
6 code of military justice proceedings related to the sexual assault or sexual harassment. The financial
7 assistance shall cover the reasonable expenses incurred from traveling to and from those proceedings.
8 This section does alter or expand a victim's right to participate in those proceedings.

9 55:2 New Paragraph; Protection of Persons from Domestic Violence; Definition Added; Military
10 Protective Order. Amend RSA 173-B:1 by inserting after paragraph XV the following new paragraph:

11 XV-a. "Military protective order" means an order issued against a current member of United
12 States Armed Forces, the New Hampshire national guard, or the national guard of another state or
13 territory by the defendant's commanding officer, on a form prescribed by the United States Department of
14 Defense.

15 55:3 Protection of Persons from Domestic Violence; Commencement of Proceedings; Hearing.
16 Amend 173-B:3, VIII to read as follows:

17 VIII. In any proceeding under this chapter, the court shall not be bound by the technical rules of
18 evidence and may admit evidence which it considers relevant and material. ***Military protective orders***
19 ***shall be admissible evidence in proceedings under this chapter.***

20 55:4 Effective Date. This act shall take effect January 1, 2026.
