AN ACT relative to disclosure of criminal history and criminal records to the child care licensing unit of the department of health and human services.

SPONSORS: Sen. Pearl, Dist 17

COMMITTEE: Children and Family Law

ANALYSIS

This bill allows the child care licensing unit of the department of health and human services to access directly from the state police an applicant's criminal history and record information and use such information as a factor to determine an applicant's eligibility.

The bill is a request of the department of health and human services.

AN ACT relative to disclosure of criminal history and criminal records to the child care licensing unit of the department of health and human services.

Be it Enacted by the Senate and House of Representatives in General Court convened:

21 licensing fund, established in RSA 170-E:7-a, on June 30, 2025 shall lapse into the state general fund.

22 80:6 Repeal. The following are repealed:

23 I. RSA 6:12, I(b)(349), relative to the child care licensing fund.

24 II. RSA 170-E:7-a, establishing the child care licensing fund.

25 80:7 Effective Date.

26 I. Section 5 of this act shall take effect June 30, 2025.

27 II. The remainder of this act shall take effect July 1, 2025.
