STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Twenty Five*

AN ACT                      relative to making electronic rent payments optional.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1            1 New Paragraph; Prohibited Practice and Security Deposits; Certain Specific Acts Prohibited.  
2 Amend RSA 540-A:3 by inserting after paragraph IX the following new paragraph:

3            X. A landlord shall not require a tenant or prospective tenant to pay any amount due under  
4 a residential lease, renewal, or extension agreement solely via electronic funds transfer, including,  
5 but not limited to, any automatic, recurring electronic funds transfers. The landlord shall allow at  
6 least one other non-electronic form of payment for the purposes of this section.

7            2 Proceedings In Special Cases; Prohibited Practices and Security Deposits; Remedies. Amend  
8 RSA 540-A:4, IX(d) to read as follows:

9            (d) The provisions of subparagraph (a) shall not apply to any violation of 540-A:3, V-a, V-  
10 b, ~~or~~ V-c, **or X**.

11           3 Effective Date. This act shall take effect January 1, 2026.
