HOUSE BILL **677-FN**

AN ACT relative to the possession and use of epinephrine at recreation camps, schools, and institutions of higher education.

SPONSORS: Rep. Drago, Rock. 4; Rep. Kuttab, Rock. 17; Rep. Nelson, Rock. 13; Rep. Soti, Rock. 35; Rep. Turer, Rock. 6; Rep. Layon, Rock. 13; Sen. Birdsell, Dist 19

COMMITTEE: Education Policy and Administration

AMENDED ANALYSIS

This bill:

I. Allows authorized entities, including recreation camps, elementary schools, secondary schools, and institutions of higher education, to possess and administer epinephrine for the treatment of anaphylaxis.

II. Removes the specific reference in current statutes to administration via auto-injectors.

III. Changes references from "physician" to "health care provider" and clarifies that epinephrine prescribed for an individual at a school or camp may also be used to treat another individual experiencing an anaphylactic emergency.

IV. Directs school districts that employ or contract with a school nurse to maintain a supply of epinephrine and establishes an epinephrine fund to provide financial support for the procurement and distribution of epinephrine to schools.

V. Clarifies authority of optometrists to administer epinephrine by injection or other methods.

AN ACT relative to the possession and use of epinephrine at recreation camps, schools, and institutions of higher education.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 204:1 Recreation Camp Licensing; Possession and Use of Epinephrine at Recreation Camps.
2 Amend RSA 170-E:59 - 170-E:62 to read as follows:

3 170-E:59 Possession and Use of Epinephrine [~~Auto-Injectors~~] at Recreation Camps. A recreation
4 camp shall permit a child with severe, potentially life-threatening allergies to possess and use [~~an~~]
5 epinephrine [~~auto-injector,~~] if the following conditions are satisfied:

6 I. The child has the written approval of the child's [~~physician~~] **health care provider** and the written
7 approval of the parent or guardian. The camp shall obtain the following information from the child's
8 [~~physician~~] **health care provider**.

9 (a) The child's name.

10 (b) The name and signature of the licensed prescriber and business and emergency
11 numbers.

12 (c) The name, route, and dosage of medication.

13 (d) The frequency and time of medication administration or assistance.

14 (e) The date of the order.

15 (f) A diagnosis and any other medical conditions requiring medications, if not a violation of
16 confidentiality or if not contrary to the request of the parent or guardian to keep confidential.

17 (g) Specific recommendations for administration.

18 (h) Any special side effects, contraindications, and adverse reactions to be observed.

19 (i) The name of each required medication.

20 (j) Any severe adverse reactions that may occur to another child, for whom the epinephrine
21 [~~auto-injector~~] is not prescribed, should such a child receive a dose of the medication.

22 II. The recreational camp administrator or, if a nurse is assigned to the camp, the nurse shall
23 receive copies of the written approvals required by paragraph I.

24 III. The child's parent or guardian shall submit written verification from the [~~physician~~] **health care**
25 **provider** confirming that the child has the knowledge and skills to safely possess and use [~~an~~] epinephrine
26 [~~auto-injector~~] in a camp setting.

27 IV. If the conditions provided in this section are satisfied, the child may possess and use the
28 epinephrine [~~auto-injector~~] at the camp or at any camp-sponsored activity, event, or program.

29 V. In this section, [~~"physician"~~] **"health care provider"** means any physician or health practitioner
30 with the authority to write prescriptions.

1 170-E:60 Use of Epinephrine [~~Auto-Injector~~]. Immediately after using [the] epinephrine [~~auto-~~
2 ~~injector~~], the child shall report such use to the nurse or another camp employee to enable the nurse or
3 camp employee to provide appropriate follow-up care.

4 170-E:61 Availability of Epinephrine [~~Auto-Injector~~]. The recreational camp nurse or, if a nurse is not
5 assigned to the camp, the recreational camp administrator shall maintain for the use of a child with severe
6 allergies at least one *dose of* epinephrine [~~auto-injector~~], provided by the child or the child's parent or
7 guardian, which shall be readily accessible to the recreational camp staff caring for children requiring such
8 medications.

9 170-E:62 Immunity. No recreational camp or camp employee shall be liable in a suit for damages as
10 a result of any act or omission related to a child's use of [an] epinephrine [~~auto-injector~~] if the provisions of
11 RSA 170-E:59 have been met, unless the damages were caused by willful or wanton conduct or disregard
12 of the criteria established in that section for the possession and self-administration of [an] epinephrine
13 [~~auto-injector~~] by a child.

14 204:2 Education; Pupil Use of Epinephrine. Amend the subdivision heading preceding RSA 200:42
15 and RSA 200:42 - 200:45 to read as follows:

Pupil Use of Epinephrine [~~Auto-Injectors~~]

16 200:42 Possession and Use of Epinephrine [~~Auto-Injectors~~] Permitted. A pupil with severe,
17 potentially life-threatening allergies may possess and self-administer [an] epinephrine [~~auto-injector~~] if the
18 following conditions are satisfied:

20 I. The pupil has the written approval of the pupil's [~~physician~~] *health care provider* and, if the pupil
21 is a minor, the written approval of the parent or guardian. The school shall obtain the following
22 information from the pupil's [~~physician~~] *health care provider*.

23 (a) The pupil's name.

24 (b) The name and signature of the licensed prescriber and business and emergency
25 numbers.

26 (c) The name, route, and dosage of medication.

27 (d) The frequency and time of medication administration or assistance.

28 (e) The date of the order.

29 (f) A diagnosis and any other medical conditions requiring medications, if not a violation of
30 confidentiality or if not contrary to the request of the parent or guardian to keep confidential.

31 (g) Specific recommendations for administration.

32 (h) Any special side effects, contraindications, and adverse reactions to be observed.

8 200:43 Use of Epinephrine ~~[Auto-Injector]~~. Immediately after using ~~[the]~~ epinephrine ~~[auto-injector]~~
9 during the school day, the pupil shall report to the nurse's office or principal's office to enable the nurse or
10 another school employee to provide appropriate follow-up care.

11 200:44 Availability of Epinephrine ~~[Auto-Injector]~~. The school nurse or, if a school nurse is not
12 assigned to the school building, the school principal shall maintain for a pupil's use at least one **dose of**
13 epinephrine ~~[auto-injector]~~, provided by the pupil, in the nurse's office or in a similarly accessible location.

14 200:44-a Anaphylaxis Training Required.

15 I.(a) Designated assistive personnel shall complete an anaphylaxis training program prior to
16 providing or administering ~~[an]~~ epinephrine ~~[auto-injector]~~ at least every 2 years following completion of
17 the initial anaphylaxis training program. Such training shall be conducted based on resources provided by
18 the National Association of School Nurses, the Food and Allergy Anaphylaxis Network, or the New
19 Hampshire School Nurses' Association. Training shall be conducted online or in person and, at a
20 minimum, shall cover:

21 (1) Techniques on how to recognize symptoms of severe allergic reactions, including
22 anaphylaxis.

23 (2) Standards and procedures for the storage and administration of ~~[an]~~ epinephrine
24 ~~[auto-injector]~~.

25 (3) Emergency follow-up procedures.

26 (b) The school nurse conducting the anaphylaxis training shall maintain a list of individuals
27 who have successfully completed the anaphylaxis training program.

28 ***(c) Designated assistive personnel shall be identified by the school nurse, in consultation***
29 ***with the principal, to ensure as many hours as possible of the school day are covered by at least one***
30 ***assistive person.***

31 II. Not later than January 1, 2017, the department of education, in consultation with the New
32 Hampshire School Nurses' Association, shall develop and make available to all schools guidelines for the
33 management of students with life-threatening allergies. The guidelines shall include, but not be limited to
34 implementation of the following by a school nurse: education and training for designated unlicensed
35 assistive personnel on the management of students with life-threatening allergies, including training
36 related to the administration of ~~[an]~~ epinephrine ~~[auto-injector]~~; procedures for responding to life-
37 threatening allergic reactions; the development of individualized health care plans and allergy action plans
38 for every student with a known life-threatening allergy; and protocols to prevent exposure to allergens.
39 Not later than September 1, 2017, each school district, under the direction of a school nurse, shall

3 available to the public.

4 200:44-b Supply of Epinephrine [~~Auto-Injectors~~].

5 I. [~~A school board may authorize a school nurse who is employed by the school district and for~~
6 ~~whom the board is responsible to maintain a supply of epinephrine auto-injectors for use in the event of an~~
7 ~~allergic emergency.~~] ***A school district shall adopt a policy to and maintain a supply of epinephrine for use***
8 ***in an allergic emergency when a nurse is employed or contracted by the district.*** The nurse shall
9 determine the quantity ***and type*** of medication the school should maintain.

10 II. To obtain life-saving allergy medication for a school district, a health care practitioner may
11 prescribe epinephrine [~~auto-injectors~~] in the name of a school district for use in life-saving allergy
12 emergency situations. ***If epinephrine is used pursuant to this subdivision, the school nurse shall order a***
13 ***replacement within 5 business days.***

14 III. A pharmacist may dispense epinephrine [~~auto-injectors~~] pursuant to a prescription issued in
15 the name of a school. A school, under the direction of the school nurse, [~~may~~] ***shall*** maintain a supply of
16 epinephrine [~~auto-injectors~~] for use in accordance with this subdivision.

17 IV. A school may enter into an agreement with a manufacturer of epinephrine [~~auto-injectors~~],
18 third-party suppliers of epinephrine [~~auto-injectors~~], or health care offices to obtain epinephrine [~~auto-~~
19 ~~injectors~~] at no charge or at fair-market prices or at reduced prices. A school district may accept gifts,
20 grants or donations from foundations, organizations, or private parties to purchase epinephrine [~~auto-~~
21 ~~injectors~~].

22 V. [~~A school that possesses and makes available a supply of epinephrine [auto-injectors]~~
23 ~~pursuant to this subdivision shall maintain an annual report summarizing the use of the epinephrine auto-~~
24 ~~injectors.~~] ***Schools shall submit an annual report to the department of education summarizing the supply***
25 ***and use of epinephrine pursuant to this subdivision.***

26 ***200:44-c Epinephrine Fund. There is hereby established in the state treasury the epinephrine fund.***
27 ***The nonlapsing fund shall be kept separate and distinct from all other funds and shall be continually***
28 ***appropriated to the department of education for the purposes of this section. The fund shall be used to***
29 ***provide financial support for the procurement and distribution of epinephrine to schools in accordance with***
30 ***RSA 200:44-b. The department may accept gifts, grants, donations, and other moneys for this purpose.***

31 200:45 Immunity.

32 I. No school district, member of a school board, or school district employee shall be liable in a
33 suit for damages as a result of any act or omission related to a pupil's use of [~~an~~] epinephrine [~~auto-~~
34 ~~injector~~] pursuant to RSA 200:43, if the provisions of RSA 200:42 have been met, unless the damages
35 were caused by willful or wanton conduct or disregard of the criteria established in that section for the
36 possession and self-administration of [~~an~~] epinephrine [~~auto-injector~~] by a pupil.

37 II. No school that possesses and makes available epinephrine [~~auto-injectors~~], member of its
38 school board, school nurse, school district employee, agents or volunteers, no health care practitioner that
39 prescribes epinephrine [~~auto-injectors~~] to a school, and no person that conducts the training described in

1 RSA 200:44-a shall be liable for damages as a result of the administration or self-administration of [an]
2 epinephrine [auto-injector], the failure to administer [an] epinephrine [auto-injector], or any other act or

4 caused by willful or wanton misconduct.

5 III. The administration of [an] epinephrine [auto-injector] by designated school personnel
6 pursuant to the provisions of this subdivision shall not require licensure.

7 IV. This section shall not be construed to eliminate, limit, or reduce any other immunity or
8 defense that may be available under state law.

9 204:3 New Subparagraph; Application of Receipts; Dedicated Fund. Amend RSA 6:12, I(b) by
10 inserting after subparagraph (399) the following new subparagraph:

11 (400) Moneys deposited in the epinephrine fund under RSA 200:44-c.

12 204:4 Epinephrine Administration in Postsecondary Educational Institutions and Independent
13 Schools; Definition of Trained Designee. Amend RSA 200-N:1, V to read as follows:

14 V. "Trained designee" means a member of the campus community trained by a licensed campus
15 medical professional in the emergency administration of [auto-injectable] epinephrine.

16 204:5 Epinephrine Administration in Postsecondary Educational Institutions and Independent
17 Schools; Emergency Administration Policies and Guidelines. Amend RSA 200-N:2 to read as follows:

18 200-N:2 Emergency Administration of Epinephrine; Policies and Guidelines.

19 I. A postsecondary educational institution or independent school accredited to operate in this
20 state may develop a policy in accordance with this chapter and guidelines issued under RSA 200-N:4
21 for the emergency administration of [auto-injectable] epinephrine to a member of the campus community for
22 anaphylaxis when a licensed campus medical professional is not available.

23 II. Such policy shall include:

24 (a) Permission for a trained designee to do the following:

25 (1) Administer [auto-injectable] epinephrine to a member of the campus community for
26 anaphylaxis when a licensed campus medical professional is unavailable.

27 (2) When responsible for the safety of at least one member of the campus community,
28 carry in a secure but accessible location a supply of [auto-injectable] epinephrine that is prescribed under
29 a standing protocol from a health care provider who is licensed in New Hampshire and whose scope of
30 practice includes the prescribing of medication.

32 designees in the following:

33 (1) The administration of [auto-injectable] epinephrine.

34 (2) Identification of an anaphylactic reaction and indications for when to use epinephrine.

35 III. Each postsecondary educational institution and independent school that develops a policy
36 under this chapter shall designate a licensed campus medical professional.

37 IV. A licensed campus medical professional may:

38 (a) Establish and administer a standardized training protocol for the emergency
39 administration of epinephrine by trained designees.

7 Schools; Storage of Epinephrine. Amend RSA 200-N:5 and 200-N:6 to read as follows:

8 200-N:5 Storage of Epinephrine.

9 I. A postsecondary educational institution or independent school may fill a prescription for [~~auto-~~
10 ~~injectable~~] epinephrine and store the [~~auto-injectable~~] epinephrine on the campus if a licensed health care
11 provider whose scope of practice includes the prescribing of medication writes the prescription for [~~auto-~~
12 ~~injectable~~] epinephrine for the postsecondary educational institution or independent school.

13 II. The postsecondary educational institution or independent school shall store the [~~auto-~~
14 ~~injectable~~] epinephrine in an unlocked safe location in which only postsecondary educational institution or
15 independent school personnel have access.

16 III. A health care provider who is licensed in this state and whose scope of practice includes the
17 prescribing of medication may write a prescription, drug order, or protocol for [~~auto-injectable~~] epinephrine
18 for the postsecondary educational institution or independent school.

19 IV. A pharmacist licensed under RSA 318 may dispense a valid prescription, drug order, or
20 protocol for [~~auto-injectable~~] epinephrine issued in the name of a postsecondary educational institution or
21 an independent school.

22 200-N:6 Immunity From Civil Liability.

23 I. A licensed campus medical professional who acts in accordance with this chapter shall not be
24 liable for civil damages for any act or omission committed in accordance with this chapter unless the act
25 or omission constitutes gross negligence or willful misconduct.

26 II. A trained designee who administers [~~auto-injectable~~] epinephrine in accordance with this
27 chapter shall not be liable for civil damages resulting from the administration of [~~auto-injectable~~]
28 epinephrine under this chapter unless the act or omission constitutes gross negligence or willful
29 misconduct.

30 III. A licensed health care provider who writes a prescription, drug order, or protocol under this
31 chapter is not liable for civil damages resulting from the administration of [~~auto-injectable~~] epinephrine
32 under this chapter unless the act or omission constitutes gross negligence or willful misconduct.

33 IV. A licensed pharmacy, whether with a physical presence or doing business through mail order,
34 that fulfills a prescription, drug order, or protocol under this chapter is not liable for civil damages resulting
35 from the administration of [~~auto-injectable~~] epinephrine under this chapter unless the act or omission
36 constitutes gross negligence or willful misconduct.

37 204:7 Epinephrine Administration in Postsecondary Educational Institutions and Independent
38 Schools; Applicability. Amend RSA 200-N:7, II and III to read as follows:

1 II. Prohibit the administration of ~~[a pre-filled auto-injector of]~~ epinephrine by a person acting under
2 a lawful prescription.

3 III. Prevent a licensed health care provider from acting within the individual's scope of practice in

5 204:8 Administration of Epinephrine. Amend RSA 329:1-h to read as follows:

6 329:1-h Administration of Epinephrine.

7 I. In this section:

8 (a) "Administer" means the direct application of ~~[an]~~ epinephrine ~~[auto-injector]~~ to the body of
9 an individual.

10 (b) "Authorized entity" means any entity or organization in which allergens capable of causing
11 anaphylaxis may be present, including recreation camps and day care facilities. Authorized entity shall
12 not include an elementary or secondary school or a postsecondary educational institution eligible to
13 establish policies and guidelines for the emergency administration of epinephrine under RSA 200-N.

14 (c) ~~["Epinephrine auto-injector" means a single-use device used for the automatic injection of~~
15 ~~a premeasured dose of epinephrine into the human body.~~

16 ~~(d)~~ (d) "Health care practitioner" means a person who is lawfully entitled to prescribe,
17 administer, dispense, or distribute controlled drugs.

18 ~~(e)~~ (d) "Provide" means to furnish one or more *doses of* epinephrine ~~[auto-injectors]~~ to an
19 individual.

20 II. A health care practitioner may prescribe epinephrine ~~[auto-injectors]~~ in the name of an
21 authorized entity for use in accordance with this section, and pharmacists and health care practitioners
22 may dispense epinephrine ~~[auto-injectors]~~ pursuant to a prescription issued in the name of an authorized
23 entity.

24 III. An authorized entity may acquire and maintain a supply of epinephrine ~~[auto-injectors]~~
25 pursuant to a prescription issued in accordance with this section. Such epinephrine ~~[auto-injectors]~~ shall
26 be stored in a location readily accessible in an emergency and in accordance with the instructions for use,
27 and any additional requirements that may be established by *the* board of medicine. An authorized entity
28 shall designate employees or agents who have completed the training required by paragraph V to be
29 responsible for the storage, maintenance, control, and general oversight of epinephrine ~~[auto-injectors]~~
30 acquired by the authorized entity.

31 IV. An employee or agent of an authorized entity, or other individual, who has completed the
32 training required by paragraph V may use epinephrine ~~[auto-injectors]~~ pursuant to this section to:

33 (a) Provide ~~[an]~~ epinephrine ~~[auto-injector]~~ to any individual who the employee agent or other
34 individual believes in good faith is experiencing anaphylaxis, or the parent, guardian, or caregiver of such
35 individual, for immediate administration, regardless of whether the individual has a prescription for ~~[an]~~
36 epinephrine ~~[auto-injector]~~ or has previously been diagnosed with an allergy.

37 (b) Administer ~~[an]~~ epinephrine ~~[auto-injector]~~ to any individual who the employee, agent, or
38 other individual believes in good faith is experiencing anaphylaxis, regardless of whether the individual
39 has a prescription for ~~[an]~~ epinephrine ~~[auto-injector]~~ or has previously been diagnosed with an allergy.

4 training unlicensed persons in emergency health care treatment or an entity or individual approved by the
5 board of medicine. Training may be conducted online or in person and, at a minimum, shall cover:

6 (1) How to recognize signs and symptoms of severe allergic reactions, including
7 anaphylaxis;

8 (2) Standards and procedures for the storage and administration of [æ] epinephrine
9 [auto-injector]; and

10 (3) Emergency follow-up procedures.

11 (b) The entity or individual that conducts the training shall issue a certificate, on a form
12 developed or approved by the board of medicine to each person who successfully completes the
13 anaphylaxis training program.

14 VI. No authorized entity that possesses and makes available epinephrine [auto-injectors] and its
15 employees, agents, and other individuals, or health care practitioner that prescribes or dispenses
16 epinephrine [auto-injectors] to an authorized entity, or pharmacist or health care practitioner that
17 dispenses epinephrine [auto-injectors] to an authorized entity, or individual or entity that conducts the
18 training described in paragraph V, shall be liable for any injuries or related damages that result from any
19 act or omission pursuant to this section, unless such injury or damage is the result of willful or wanton
20 misconduct. The administration of [æ] epinephrine [auto-injector] in accordance with this section shall not
21 be considered to be the practice of medicine or any other profession that otherwise requires licensure.
22 This section shall not be construed to eliminate, limit, or reduce any other immunity or defense that may
23 be available under state law. An entity located in this state shall not be liable for any injuries or related
24 damages that result from the provision or administration of [æ] epinephrine [auto-injector] outside of this
25 state if the entity would not have been liable for such injuries or related damages had the provision or
26 administration occurred within this state, or is not liable for such injuries or related damages under the law
27 of the state in which such provision or administration occurred.

28 204:9 Dealing In or Possessing Prescription Drugs. Amend RSA 318:42, VII-a(b) to read as follows:

29 (b) The possession and administration of epinephrine for the emergency treatment of
30 anaphylaxis by licensed practical nurses or registered nurses employed or contracted by public school
31 systems or by licensed campus medical professionals in postsecondary educational institutions or
32 independent schools. *A pharmacist may dispense epinephrine pursuant to a prescription issued in the*
33 *name of a school, postsecondary institution, or independent school. A school, under the direction of the*
34 *school nurse, may maintain a supply of epinephrine for use in accordance with RSA 200:44-b and RSA*
35 *200-N:5. The emergency treatment of anaphylaxis by licensed practical nurses or registered nurses*
36 *employed or contracted by public school systems or by licensed campus medical professionals in*
