AN ACT relative to procedures for the closing of a charter school.

SPONSORS: Rep. Cordelli, Carr. 7; Rep. Ladd, Graf. 5; Sen. Watters, Dist 4

COMMITTEE: Education Policy and Administration

AMENDED ANALYSIS

This bill adds to the procedures for the closing of a chartered public school, requires records to be kept either by a chartered public school, or in the event of its closure, by the department of education, for 60 years, and establishes the closed charter schools fund for the collection of transcript request fees.

AN ACT relative to procedures for the closing of a charter school.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 289:1 Charter Revocation; Probation. RSA 194-B:16 is repealed and reenacted to read as follows:

2 194-B:16 Charter Revocation; Probation.

3 I. After reasonable notice has been provided to all affected parties, the state board may revoke a
4 school's charter prior to the expiration of its term under the following circumstances:

5 (a) The school commits a material violation of any of the conditions, standards, or procedures
6 set forth in its charter application and contract.

7 (b) The school fails to meet generally accepted standards for fiscal management.

8 (c) The school significantly violates the law.

9 (d) The school makes a material misrepresentation in its application or contract application.

10 (e) The school becomes insolvent or financially unstable.

11 (f) The school fails to comply with the reporting requirements in accordance with RSA 198:4-

12 f.

13 (g) The school fails to comply with state or federal reporting requirements.

14 (h) The school fails to remedy the causes of its probation.

15 (i) The school fails to be in good standing with the charitable trust units pursuant to RSA 7.

16 II. Written petition to the state board to revoke a school's charter may be requested by the parent
17 of any pupil currently attending that chartered public school, or by the school board of a host or receiving
18 school district.

19 III. Before revoking a school's charter, the state board shall consult with the school board and the
20 board of trustees on the development and implementation of a remedial plan for the school to address
21 specific areas of concern.

22 IV. The state board may place a chartered public school on probationary status for up to one year
23 to allow the implementation of a remedial plan, after which, if the plan is unsuccessful, the charter shall be
24 revoked. The board may impose conditions on the school's charter that require the school to address
25 specific areas of concern. Placing a school on probation signals concern about the school and permits
26 the board to revoke a school's charter immediately if the school fails to remedy the causes of its probation.
27 The department may require a charter school on probation to establish an escrow account in an amount
28 determined by the department in consultation with the charter school to pay for closing, legal, and audit
29 expenses associated with closure should that occur.

30 V. Nothing contained in this section shall prevent the state board from immediately revoking a
31 school's charter in circumstances posing extraordinary risk of harm to pupils.

1 VI. By the end of its final contract year, the chartered public school shall meet or exceed the
2 objective academic test results or standards and goals as set forth in its application. If the school does
3 not meet these results or standards and goals, it shall not be eligible for renewal of its charter.

4 VII. If a school's charter expires or is revoked, the school shall be dissolved under the provisions
5 of its charter application and contract. If the contract provisions are silent or ambiguous as to disposition
6 of any asset of the school, such asset shall revert to the school district in which the chartered public
7 school is located at no cost to that district, subject to the school district's acceptance of the asset. Under
8 no circumstances shall the school district be liable for any obligations of the dissolved chartered public
9 school.

10 VIII. If a school's charter expires or is revoked, the parent of a pupil attending that school may
11 apply to any other chartered public school eligible to receive tuition under the provisions of this chapter
12 adopted by the school district. The pupil's sending district shall not be relieved of its obligation to educate
13 that pupil in accordance with the district's policies.

14 289:2 New Section; Charter Closure; Records. Amend RSA 194-B by inserting after section 16 the
15 following new section:

16 194-B:16-a Charter Closure; Records.

17 I. If a chartered public school closes due to revocation of its charter or any other reason, all
18 records shall be transferred electronically to the department. The department shall act as custodian of
19 records for all closed chartered public schools and shall preserve these records for 60 years. Charter
20 schools, if operational, shall maintain student records for 60 years.

21 II. Student records shall include personal information, entering and leaving date of each school
22 year, subjects taken during each year, grades, credits awarded, health information, state assessment
23 results, disciplinary actions, and special education records pursuant to RSA 186-C:10-a.

24 III. The department shall provide information on its website about how the request student or
25 personnel records from the closed charter school.

26 IV. The department shall establish a fee schedule association sufficient to cover related costs for
27 the maintenance and furnishing of records pursuant to this section.

28 V. The department, upon request of the individual concerned and receipt of required fees, shall
29 furnish a certified copy of the individual's record.

30 VI. All transcript request fees collected by the department under this section shall be deposited
31 into a non-lapsing fund at the department, and shall be used for managing the storage and retrieval of
32 closed charter school transcripts.

33 VII. The state board of education may adopt rules under RSA 541-A concerning the preserving of
34 the records, and furnishing copies, including fees.

35 VIII. There is hereby established in the department of education the closed charter schools fund.
36 The fund shall be comprised of transcript fees collected by the department after the closure of a charter
37 school. The fund shall be non-lapsing and shall be continually appropriated to the department.
