HOUSE BILL **1362**

AN ACT relative to motor vehicle equipment specifications.

AMENDED ANALYSIS

This bill establishes motor vehicle standards for tire tread depth and brake lining measurements and inspection standards for vehicle steering and suspension systems.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty-Six

AN ACT relative to motor vehicle equipment specifications.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Section; Equipment of Vehicles; Tire Tread Depth. Amend RSA 266 by inserting after
2 section 48 the following new section:

3 266:48-a Tire Tread Depth; Measurement Requirements.

4 I. No person shall drive a motor vehicle upon any way unless each tire mounted thereon has
5 a minimum tread depth of not less than 2/32 of an inch.

6 II. Notwithstanding any other provision of law to the contrary, this section shall not apply
7 to:

8 (a) Commercial motor vehicles, as defined in RSA 259:12-e, that exceed 10,000 pounds in
9 weight.

10 (b) School buses, as defined in RSA 259:96, that exceed 10,000 pounds in weight.

11 (c) Mixed use school buses, as defined in RSA 259:96-a, that exceed 10,000 pounds in
12 weight.

13 2 New Section; Equipment of Vehicles; Brake Performance; Brake Lining Measurements.
14 Amend RSA 266 by inserting after section 28 the following new section:

15 266:28-a Brake Lining Measurement; Lining Thickness.

16 I. No person shall drive a motor vehicle upon any way unless the brake lining or friction
17 material at each wheel has a minimum thickness of 2/32 of an inch.

18 II. Brake lining measurements shall be performed using a brake gauge, caliper, or other
19 suitable measuring device calibrated in thirty-seconds of an inch.

20 (a) For brake shoes or disc brake pads with riveted linings, measurements shall be taken
21 to the top of any rivet head.

22 (b) For brake shoes or disc brake pads with bonded linings, measurements shall be
23 taken at the thinnest point of the friction material.

24 III. Notwithstanding any other provision of law to the contrary, this section shall not apply
25 to:

26 (a) Commercial motor vehicles, as defined in RSA 259:12-e, that exceed 10,000 pounds in
27 weight.

28 (b) School buses, as defined in RSA 259:96, that exceed 10,000 pounds in weight.

29 (c) Mixed use school buses, as defined in RSA 259:96-a, that exceed 10,000 pounds in
30 weight.
