HOUSE BILL **1298**

AN ACT relative to the disposal of electronic ballot counting device external memory devices.

SPONSORS: Rep. Berry, Hills. 44

COMMITTEE: Election Law

AMENDED ANALYSIS

This bill requires the external memory devices from certain electronic ballot counting devices to be destroyed in the same way as ballots.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty-Six

AN ACT relative to the disposal of electronic ballot counting device external memory devices.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Disposal and Retention Schedule; Electronic Ballot Counting Device External Storage Devices.
2 Amend RSA 33-A:3-a, XXXVI-XXXVII to read as follows:

3 XXXVI. Elections-federal elections: ballots and absentee ballot applications, affidavit
4 envelopes, lists, and electronic ballot counting device external storage devices: by the town clerk
5 until the contest is settled and all appeals have expired or at least 22 months after the election,
6 whichever is longer. Extra electronic ballot counting device external storage devices programmed
7 for, but not used during the election are exempt from preservation. ***The external storage devices***
8 ***of electronic ballot counting devices, including those that capture digital images, shall be***
9 ***disposed of in the same manner as ballots, absentee ballot applications, affidavit***
10 ***envelopes, and lists. Disposal may be achieved by either physically destroying the storage***
11 ***device or by secure erasure that permanently destroys all election-related data on the***
12 ***storage device, including election programming, vote tallies, and digital images.***

13 XXXVII. Elections-not federal: ballots and absentee ballot applications, affidavit envelopes,
14 lists, and electronic ballot counting device external storage devices: by the town clerk until the
15 contest is settled and all appeals have expired or at least 60 days after the election, whichever is
16 longer. Extra electronic ballot counting device external storage devices programmed for, but not
17 used during the election are exempt from preservation. ***The external storage devices of***
18 ***electronic ballot counting devices, including those that capture digital images, shall be***
19 ***disposed of in the same manner as ballots, absentee ballot applications, affidavit***
20 ***envelopes, and lists. Disposal may be achieved by either physically destroying the storage***
21 ***device or by secure erasure that permanently destroys all election-related data on the***
22 ***storage device, including election programming, vote tallies, and digital images.***

23 2 Effective Date. This act shall take effect 60 days after its passage.
