HOUSE BILL **352-FN**

AN ACT prohibiting possession of a firearm at a polling place.

SPONSORS: Rep. Horrigan, Straf. 10; Rep. Meuse, Rock. 37; Rep. Newell, Ches. 4; Rep. Selig,

COMMITTEE: Criminal Justice and Public Safety

ANALYSIS

This bill prohibits possessing a firearm at a polling place and includes certain exceptions. This bill further allows individuals who are unwilling or unable to comply with this prohibition to vote by absentee ballot.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Five

AN ACT prohibiting possession of a firearm at a polling place.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Subdivision; Firearms Prohibited at Polling Places. Amend RSA 159 by inserting after
2 section 27 the following new subdivision:

3 Firearms Prohibited at Polling Places

4 159:28 Firearms Prohibited at Polling Places.

5 I. No person shall knowingly carry a loaded or unloaded pistol, revolver, firearm, or other
6 deadly weapon as defined in RSA 625:11, V, whether open or concealed, or whether licensed or
7 unlicensed, within 100 feet of a polling place during a federal, state, or municipal election.

8 II. Any person who violates the provisions of this section shall be guilty of a class A
9 misdemeanor.

10 159:29 Exceptions. The provisions of RSA 159:28 shall not apply to:

11 I. Law enforcement officers on duty at the polling place.

12 II. Uniformed law enforcement officers while they are exercising their right to vote.

13 III. Non-uniformed law enforcement officers who are conceal-carrying their service weapon
14 while they are exercising their right to vote.

15 IV. A person who secures an unloaded firearm in a motor vehicle while at the polling place.

16 2 Absentee Voting; Eligibility. Amend RSA 657:1, I to read as follows:

17 I. Any person who will be absent on the day of any state election from the city, town, or
18 unincorporated place in which he or she is registered to vote or who cannot appear in public on any
19 election day because of his or her observance of a religious commitment or who is unable to vote
20 there in person by reason of physical disability may vote at such elections as provided in this
21 chapter. A person who is unable to appear at any time during polling hours at his or her polling
22 place because of an employment obligation *or because he or she is unwilling or unable to*
23 *comply with the prohibition of firearms at polling places in RSA 159:28* shall be considered
24 absent for purposes of this chapter. For the purposes of this section, the term "employment" shall
25 include the care of children and infirm adults, with or without compensation.

26 3 Absentee Voting; Application; Forms. Amend RSA 657:4, I to read as follows:

27 I. Prior to any state election, the secretary of state shall prepare the appropriate application
28 forms for absentee ballots worded in substantially the following form. The secretary of state shall
29 insert the names of all parties qualified as set forth in RSA 652:11 in the list of parties on the
30 application form. The secretary of state shall prepare the application forms in such quantity as he or
31 she deems necessary:

1 Absence (Excluding Absence Due to Residence Outside the United States), Religious Observance,
2 and Disability:

3 I hereby declare that (check one):

4 I am a duly qualified voter who is currently registered to vote in this town/ward.

5 I am absent from the town/city where I am domiciled and will be until after the next election,
6 or I am unable to register in person due to a disability, and request that the forms necessary for
7 absentee voter registration be sent to me with the absentee ballot.

8 I will be entitled to vote by absentee ballot because (check one):

9 I plan to be absent on the day of the election from the city, town, or unincorporated place
10 where I am domiciled.

11 I am confined in a penal institution for a misdemeanor or while awaiting trial.

12 I am requesting a ballot for the presidential primary election and I may be absent on the day
13 of the election from the city, town, or unincorporated place where I am domiciled, but the date of the
14 election has not been announced. I understand that I may only make such a request 14 days after
15 the filing period for candidates has closed, and that if I will not be absent on the date of the election I
16 am not eligible to vote by absentee ballot.

17 I cannot appear in public on election day because of observance of a religious commitment.

18 I am unable to vote in person due to a disability.

19 I cannot appear at any time during polling hours at my polling place because of an
20 employment obligation. For the purposes of this application, the term "employment" shall include
21 the care of children and infirm adults, with or without compensation.

22 ***I am unwilling or unable to comply with the prohibition of firearms at polling places***
23 ***in RSA 159:28.***

24 For use only on the Monday immediately prior to the election: I cannot appear at my polling place on
25 election day because the National Weather Service has issued a winter storm warning, blizzard
26 warning, or ice storm warning for election day applicable to my city, town, or unincorporated place
27 and either (check one):

28 I am elderly or infirm or I have a physical disability, and would otherwise vote in person but I
29 have concerns for my safety traveling in the storm.

30 I anticipate that school, child care, or adult care will be canceled, and would otherwise vote in
31 person but will need to care for children or infirm adults.

32 Any person who votes or attempts to vote using an absentee ballot who is not entitled to vote by
33 absentee ballot shall be guilty of a misdemeanor. RSA 657:24.

27 If your absentee ballot application or affidavit envelope has the printed name and signature of a
28 person who assisted you with voting, your signature will not be compared to your signature on the
29 absentee ballot affidavit to verify your identity. Otherwise, if your signatures do not appear to be
30 made by the same person, your absentee ballot may not be counted.

31 The applicant must sign this form to receive an absentee ballot. Any person who witnesses and
32 assists a voter with a disability in executing this form shall print and sign his or her name in the
33 space provided on the application form. The moderator will not compare the voter's signature on the
34 application with the signature on the absentee ballot affidavit when a person assisting the voter has
35 signed the statement on the absentee ballot application or affidavit envelope that assistance was
36 provided.

37 4 Absentee Ballots and Related Materials. Amend RSA 657:7, II to read as follows:

1 II. Affidavit envelopes of sufficient size to contain the ballots on which shall be printed the
2 following:

3 YOUR COMPLETED ABSENTEE BALLOT MUST BE SEALED IN THIS ENVELOPE

4 I do hereby certify under the penalties for voting fraud set forth below that:

5 I am a voter in the city or town of _____, New Hampshire.

6 One of the following applies to me:

7 1) I will be absent on election day. Absence includes:

8 a) I will be out-of-town on election day.

9 b) I will be unable to vote in person because I will be working.

10 c) I will be unable to vote in person because I will be caring for children or infirm adults, with or
11 without compensation.

12 d) I am voting absentee on the Monday immediately before the election, the National Weather
13 Service has issued a winter storm warning, blizzard warning, or ice storm warning that applies to
14 my town/ward, and I have concerns for traveling in the storm.

15 2) I am unable to vote in person due to disability.

16 3) I am unable to vote in person due to observance of a religious commitment, which prevents me
17 from voting in person.

18 4) I am confined to a penal institution for a misdemeanor or while awaiting trial.

19 **5) I am unwilling or unable to comply with the prohibition of firearms at a polling place.**

20 I have carefully read or had read to me the absentee voting instructions. I personally marked the
21 absentee ballot enclosed in this envelope or, due to a disability, I had assistance in marking the
22 absentee ballot.

23 Voter Signature _____

24 A person assisting a voter with a disability shall sign this statement on this envelope acknowledging
25 the assistance.

26 I attest that I assisted (print voter name) _____ because the voter is a person with a
27 disability. I marked the ballot and/or this form as instructed by the voter.

28 In accordance with RSA 659:34, the penalty for knowingly or purposefully providing false
29 information when registering to vote or voting is a class A misdemeanor with a maximum sentence
30 of imprisonment not to exceed one year and a fine not to exceed \$2,000. Fraudulently registering to
31 vote or voting is subject to a civil penalty not to exceed \$5,000.

32 5 Effective Date. This act shall take effect January 1, 2026.
