AN ACT relative to funding the Hampton Beach area commission and making appropriations therefor.

ANALYSIS

This bill includes operations and initiatives of the Hampton Beach area commission in the uses for the Hampton Beach master plan fund. This bill also makes an appropriation to the Hampton Beach master plan fund.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Five

AN ACT relative to funding the Hampton Beach area commission and making appropriations therefor.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Hampton Beach Master Plan Fund. Amend RSA 216-J:5 to read as follows:

2 216-J:5 Hampton Beach Master Plan Fund. There is hereby established in the office of the state
3 treasurer a fund to be known as the Hampton Beach master plan fund which shall be kept separate
4 and distinct from all other funds and shall be continually appropriated to the commission. Such
5 fund shall be the depository of all gifts, grants, ~~or~~ donations made to the commission pursuant to
6 RSA 216-J:4, **and any other funds appropriated pursuant to this section.** Implementation
7 expenses, the expenses of the commission, its commissioners, ~~and~~ any employees of the
8 commission, **and operations and initiatives of the commission,** shall be paid from such fund.
9 Any moneys in such fund shall not lapse into the general fund of the state.

10 2 Appropriation.

11 I. A sum of \$5,000 is hereby appropriated to the Hampton Beach master plan fund
12 established under RSA 216-J:5 for the fiscal year beginning July 1, 2025, and ending June 30, 2026,
13 for the purposes of funding the operations and initiatives of the commission.

14 II. A sum of \$5,000 is hereby appropriated to the Hampton Beach master plan fund
15 established under RSA 216-J:5 for the fiscal year beginning July 1, 2026, and ending June 30, 2027,
16 for the purposes of funding the operations and initiatives of the commission.

17 III. The governor is authorized to draw a warrant for said sums out of any money in the
18 treasury not otherwise appropriated.

19 3 Effective Date. This act shall take effect July 1, 2025.
