

**Public Hearing Schedule and Timeline for Adoption of House Redistricting Bill  
2011-2012**

HB 592 as introduced in 2011, included House districts, Congressional districts, Executive Council, County Commissioner districts. A public hearing was held on March 4, 2011 and the bill was retained in the committee in an executive session held on March 10, 2011.

The House deadline to report HB 592 was December 23, 2011. As amended by the House and ultimately adopted, the bill included only the House districts, a deadline for the adoption of ward boundaries for redistricting, and the revised ward lines for Portsmouth. Bills to establish Executive Council districts (HB 1670), county commissioner districts (HB 1717) and delegate districts (HB 1672) were introduced in and adopted in 2012.
