Lawn Installation Seeding	This following includes the lawn directly behind the house on the right side where the septic area damage is up to the pine tree with the hosta: We will start by cleaning up the piles of rocks and sticks in the grass. All of this debris will be taken off site. Then we will grade the existing ground lightly and will add (15) yards of loam to fix the uneven areas in the septic area. The loam will be spread, rolled and then finished raked. This includes spreading high quality seed over the new loam and an application of lime and starter fertilizer at this point as well. The new seed must be watered enough to keep the soil moist throughout the day. This must be done until the seed has established. Once the seed has established the client can water it like an established lawn (depending on the weather and temperatures). The client is 100% responsible for proper watering. It is also recommended that the client has another application of fertilizer spread over the new seed once it reaches an inch for the best results. Divine highly recommends hiring a company to treat the clients lawn throughout the spring, summer and fall. This will help prevent grubs, weeds, etc. from damaging the lawn.	2,945.00
