Director Osterhoudt identified a clerical error in the paper copies of the agenda before the Committee which cited the rule contained in FP 2025-246, item (b) of the consent agenda, as Bar 500. The correct rule was Bar 402, and the agenda had been updated accordingly.

Sen. Lang moved that the Committee approve the Consent Agenda, that is, approve Final Proposals 2025-222, 2025-246, 2025-270, 2025-271, 2025-274, 2025-275, 2025-279, 2025-280, and 2025-281, and Interim Rule 2026-1; and conditionally approve Final Proposals 2025-172, 2025-175, 2025-210, 2025-253, 2025-276, 2025-277, 2025-278, and 2025-288, based on the agencies' Conditional Approval Requests or amended Conditional Approval Requests.

Sen. Ward seconded.

Adopted.

5. The Committee discussed Final Proposal 2025-156 from the Department of Transportation (Off-Premise Outdoor Advertising). Administrative Law Judge Stephen Labonte and Manager Lee Baronas testified on behalf of the Department.

Sen. Lang asked how the Department denied a request from Plymouth State University (PSU) if there were no rules in place. The Department answered the request from PSU was denied pursuant to other controlling federal regulations and statute.

Sen. Lang moved to conditionally approve Final Proposal 2025-156.

Rep. Grote seconded.

Adopted.

6. The Committee discussed Final Proposal 2025-161, and Final Proposal 2025-194, from the Department of Safety, Commissioner (Administrative License Suspension (ALS) Rules; Rules for Railroad Police). Director John Marasco testified on behalf of the Department.

At the Department's request, Rep. McGuire moved to postpone the hearing on Final Proposal 2025-161, and Final Proposal 2025-194, to the March 20, 2026, Committee meeting, and waive the March 16, 2026, Committee action deadline for Final Proposal 2025-161.

Rep. Layon seconded.

Adopted.

7. The Committee discussed Final Proposal 2025-168 from the Board of Architects (Initial License Requirements, Qualifications, Examinations, Reciprocity, Fees, and Credentials). Chantell Wheeler, Rules Administrator for the Office of Professional Licensure and Certification, testified on behalf of the Board.

Representative Grote moved to conditionally approve Final Proposal 2025-168.

Rep. Layon seconded.

Adopted.

8. The Committee discussed Final Proposal 2025-207 from the Department of Agriculture, Markets, and Food (Farm Products and Lumber Standards). Director Allen Wyman, and Patricia Benner, Legislative Coordinator, testified on behalf of the Department.

The Committee raised concerns about a 20-year gap between the expiration of the previous rule and the submission of Final Proposal 2025-207.

Based on the Department's response, Sen. Lang moved to postpone action on Final Proposal 2025-207 to the March 20, 2026, Committee meeting, and waive the February 20, 2026, Committee action deadline to allow for additional legal review of the statutory authority of the proposed rule.

Rep. Grote seconded.

Adopted.

9. The Committee discussed Emergency Rule 14504 from the Department of Safety, Commissioner (Fee Updates to DMV Forms as a Result of 2025 NH Laws ch 141). The Committee took no action.
10. The Committee discussed Emergency Rule 14515 from the New Hampshire Liquor Commission (New Tobacco Licensing and Seizure Rules). The Committee took no action.
